- \* The area prescribed by me and as well the areas to the bottom of the east and south and to the east boundary of the Devalaya.

06. Trades are totally prohibited in the camp area; in areas except mentioned by the above 04th and 05th statements.

07. Parking provide vehicles at the main road is totally prohibited. All the traffic including bicycles and carts cannot be taken into the camp area devoid of a license issued by the officer in charge of the camp.

08. Notice will be published for marking aware of the procedures of leasing of lands for trade in charge of the camp.
09. The temporary constrictions in the leased lands must be under the instruction of the health departments. As the festival is over, the trades themselves have to take off the temporary building and refusals including polythene should be disposed under the public health inspector's instructions.
10. Only the vehicles having the license for the Esala Perehara festival are allowed to the enter the festival premises. Accordingly, the following routes are not allowed for vehicles to take in.
11. Dewala premises access road by Colombo-Badulla road *via* divisional secretariat junction.
- \* Dewala premises access road *via* Thotapalla and Pokunegama.
- \* Dewala premises access road *via* Prithwaththa, Galwaththa Devala area.
- \* Permitted vehicles that reach Devala Premises can be parked at the school Ply Ground.
12. It is completely prohibited to photograph and vedio the "Diggaya" and upper floor of the devalaya without permission.

#### Significant Accounting Policies

##### 1. General

The Financial Statements of the University have been prepared in conformity with the generally accepted accounting principles and the Sri Lanka Public sector Accounting Standards (SLPSAS) on Historical Cost convention. Transactions recorded at the value prevailing at the dates when the assets were acquired, the liabilities were incurred and funds received in accordance with Generally Accepted Accounting Principles and are consistent with those used in the previous years.

##### 1.1 Comparative Information

To Facilitates comparison, relevant balances pertaining to the previous year have been reclassified to confirm to current years classification and presentation.

##### 2. Assets and the basis of their valuation

##### 2.1 Property, Plant and Equipment and Depreciation

The Property, Plant and Equipment are shown at cost less accumulated depreciation. All assets have been recorded at cost of purchase with incidental expenses. Assets received as donations have been valued at their cost.

The value of Property, Plant and Equipment received as donation were capitalized and amortized as revenue over the useful life of the related asset as per SLPSAS 07.

Depreciation is charged on Straight-Line basis at the following rates per annum in order to write off the cost of such assets over their estimated useful life.

## 2.2 Inventories

The First in First Out method (FIFO) is adopted to value cost of inventories. Inventories were physically verified and valued at cost to ascertain the current value as at the Balance Sheet date.

## 2.3 Loans and Advances to Staff :

Actual Loan Balance to be recovered from staff members is considered as receivable.

## 3. Provisions for Gratuity

Provisions for gratuity has been calculated as per the Gratuity Act, No. 12 of 1983. This provision is not externally funded.

## 4. Provision for Accruals and Liabilities

Provision for Accruals and Liabilities are provided based on the estimations and available supporting documents.

## 5. Receivables

A sum of Rs. 96,325,693.84 is due from employees on account of Breach of Contracts as at 31.12.2013. After considering the nature of receivable and amount received on violation of bond and obligations it is decided to change the accounting policy from the accrual basis to the cash basis with effect from 01st January, 2011. Therefore Rs. 68,253,385.42 shown in note 05.01 is relevant only for the period up to the 31st December, 2010.

## 6. Accounting for Grants

Recurrent grants are recognized in the Income and Expenditure Statement on cash basis. Cost of rehabilitation of Fixed Assets and Capital Grants for construction and new work recognized either as work in progress or Capital Assets where necessary.

## 7. Income Recognition

7.1 Government Grants for Recurrent Expenditure, Student Bursaries and Mahapola were recognized on cash basis.

7.2 Revenue is recognized in cash basis over the period of instruction to match with the relevant expenditure of the respective course.

## 8. Prior Period Errors

Prior period errors in calculation of depreciation and amortization of special grant of IRQUE (IDA Credit 3781 CE) project have corrected during this period. Accordingly corrections were done retrospectively and restated the comparative figures. (Schedule E).

## 9. Accounting for Government Grant for Capital Expenditure

Government Grant for the capital expenditure has presented in the financial statements in accordance with the LKAS 20. According to the accounting standard capital grant has recognized as deferred income in the statement of financial position and amortized over the useful life of the asset.
