Press and from the date of publication, thereby enabling those interested in the contents of such notices to actively and positively participate please note that inquiries and complaints made in respect of corrections pertaining to notification will not be entertained after **three months** from the date of publication.

All notices to be published in the weekly *Gazettes* should reach Government Press two weeks before the date of publication *i.e.* Notices for publication in the weekly *Gazette* of 16th October 2015, should reach Government Press on or before 12.00 noon on 02nd October 2015.

#### Electronic Transactions Act, No. 19 of 2006 - Section 9
