1. General Qualifications required:

- 1:1 Every applicant must furnish satisfactory proof that he is a Sri Lankan. A "Sri Lankan" is a citizen of Sri Lanka by descent or by registration as defined in the Sri Lanka Citizenship Act.
- 1:2 A candidate for any post for which the minimum educational qualification prescribed is a pass in the Senior School Certificate Examination or equivalent or higher examination, should have a pass in the Senior School Certificate Examination or equivalent or higher examination, should have a pass either in Sinhala language or Tamil language obtained, as the case may be, at the Senior School Certificate Examination or its equivalent if he is either a Sinhalese educated in Sinhala Medium or if he is a Tamil educated in Tamil Medium (This requirement will not apply to those who are in the public service from a date prior to January 01,1961, and who seek appointments to other posts in the public service).
- 1:3 Application from the "New Entrants" Public Officers, who are not either Sinhala or Tamil educated, whose probationary trial appointments have been terminated for failure to pass the prescribed official language proficiency tests will not be entertained unless they have obtained the qualifications which could entitle them to seek exemptions from the highest proficiency test prescribed for the post.
 - 2. Conditions of Service-General:
- 2:1 All officers in the Public Service will be subject to the Financial Regulations, the Establishments Code, Departmental Orders or Regulations and any other Orders or Regulations that may be issued by the Governments from time to time.
- 2:2 A Public officer may be required to furnish security in terms of the Public Officers (Security) Ordinance, in such sum and in such manner as the secretary to the Ministry concerned may determine.
- 2:3 A Public Officer may be called upon to serve in any part of the Island.
- 3. Conditions of Service applicable to Public Officers holding permanent appointments:
- 3:1 In addition to the conditions referred to in Section 2 above Public Officer holding permanent appointments will be subject to the following further conditions:
- 3:1:1 All appointments will be on probation for a period of 3 years unless a longer period is considered necessary in respect of any post. Any appointment may be terminated at any time during the period of probation without a reason being assigned.
- 3:1:2 All public officers are required to conform to the provisions of the Chapter IV of the Constitution of the Democratic Socialist Republic of Sri Lanka and any other laws, regulations or rules that may be made from time to time to give effect to the Language Policy of the Government.
- 3:1:3 All Public officers who have not entered the Public Service either in Sinhala Medium or in Tamil Medium are required to acquire a working knowledge in one of the official languages.
- 3:1:4 Confirmation at the expiry of the period of probation of an officer who entered the Public Service in a medium other than Sinhala or Tamil will depend, inter alia, on the passing of the Grade 1 Proficiency Test in one of the Official Languages within one year; Grade II Proficiency Test within two years, and Grade III Proficiency Test (where applicable) within three years from the date of appointment.

Faliure to pass a test within the prescribed period will result in the suspension of increments. Suspension will be converted to a stoppage if the test is not passed within a further period of six months beyond the prescribed period such stoppage operating until the test is passed or until such time as the provisions of Section 3:1:6 below apply.

- 3:1:5 Such officers should, on receiving appointment, be given facilities on full pay, for a period of 6 months to obtain proficiency in one of the official languages. He will thereafter, be required to sit the relevant proficiency examination and if he does not pass he will be given the opportunity to pass the examination within a period of 2 years immediately after the period of 6 months on full pay, while he performs his normal duties.
- 3:1:6 If he fails to pass the examination in this prescribed period of 2 1/2 years his services will be terminated.
- 3:1:7 A Public Officer already confirmed in permanent post in the Public Service will not normally be required to serve the period of probation on being appointed to another permanent post in the Public

Service. Such Officers may in the first instance be appointed to act in the new post for a specified period with a view to testing him in his new post.

3:1:8 Selected candidates (Other than those already holding permanent or temporary appointments in the Public Service) who have already been medically examined will be required to undergo a medical examination by a Government Medical Officer to test their physical fitness to serve in any part of the Island.

4. Terms of Engagement:

- 4:1 Public officers appointed to permanent and pensionable posts should contribute to the 'Widows and Orphans' Pension Scheme from their salary an amount equivalent to the percentage the Government requires to recover from their salary.
- 4:2 Public officers appointed to permanent or temporary posts on Provident Fund basis will be required to contribute 6% of their consolidated salary to the Public Service Provident Fund. The Government will contribute as its share of contributions an amount equal to 150% of the compulsory contributions credited to the fund at the close of the Financial Year.
- 4:3 Officers who hold pensionable appointments in the Public Service and who are released for appointments to pensionable posts in the Local Government Service and those officers in the Local Government Service who hold pensionable appointments and who are released for appointments to pensionable posts in the Public Service will be allowed pensionability in their posts in the Local Government Service and Public Service respectively.
- 4:4 Regular Force personnel in the Army, Navy and Air Force who are released for appointments to posts in the Public Service which are pensionable under the Minutes on Pension will be allowed pensionability in their posts in the Public Service. Notwithstanding anything to the contrary in these Minutes the unforefeited full pay service of any member of the Armed Forces who is released to accept an appointment as a Public Officer in a post which has been declared to be pensionable under these Minutes shall be reckoned for the purpose of any pension or gratuity payable under these Minutes.
 - 5. Serving Officers in the Public Service:
- 5:1 Applications from officers of the Public Service who possess all the necessary qualifications must be forwarded through the Heads of their respective Departments. In the case of applications from Public Officers holding post in the permanent establishment in the Public Service. Heads of Departments in forwarding such applications should state whether the applicants could be released or not to take up the new appointment, if selected.
- 5 :2 Candidates may be required to present themselves for interview at an appointed time and place. No travelling or other expenses will be paid in this connection.
- 5 :3 Anyone desiring to recommended a candidate should do so by giving a testimonial. Any form of canvassing or any attempt to influence the selection of a candidate will disqualify such candidates.
- 5:4 Any statement in the application which is found to be incorrect will render the applicant liable to disqualification if the inaccuracy is discovered before the selection and to dismissal if discovered after the selection.
- 5:5 Application not conforming in every respect with the requirements of the advertisement will be rejected.
 - 6. Definition of Salary for the purpose of Eligibility
- 6:1 Salary for purposes of eligibility means only the consolidated salary and does not include any action salary, allowances etc.
 - 7. New National Policy on Recruitment and Promotions:

Recruitment and Promotion in the Public Service, Provincial Public Service, Public Corporate Sector and Companies fully owned by the Government will be done in accordance with the policy laid down in the Public Administration Circulars No. 15/90 of 09.03.1990, 15/90 (I) of 25.03.1990 & 15/90 (ii) of 15.06.1990 with effect from 01.01.1990 subject to amendments that will be done by subsequent Public Administration Circulars.

Rules and Instructions for Candidates

"All candidates are bound to act in conformity with the provisions of the Examinations Act, No. 25 of 1968.

All candidates are bound to abide by the rules given below. A candidate who violates any of these rules is liable to one or more of the following punishments at the discretion of the Commissioner of Examinations :-

- (i) Suspension from the whole or part of the examination or one subject or a part thereof;
- (ii) Disqualification from one subject or from the whole examination; (iii) Debarment from appearing for an examination for a period of one year or two years;
- (iv) Debarment for life;
- (v) Suspension of the certificate for a specified period;
- (vi) Reporting the candidate's conduct to his Superiors or handing over the candidate to the Police or making a complaint to the Police over

The Commissioner reserves himself the right to take action at any time before the Examination or at any stage of it or thereafter, and his decision shall be deemed final. In the case of examinations for recruitment to the Public Service, the decision of Commissioner of Examinations shall be subject to the Supervision of the Public Service Commission.

1. All candidates should conduct themselves in a quiet manner in and around the Examination Hall so as not to disturb or obstruct the Supervisor, his assistants or the other candidates. They should enter and

- leave the Examination Hall as quietly as possible.

 2. Candidates should obey the Supervisor. Therefore, when the Examination is in progress and before the commencement of the Examination as well as immediately after the end of the Examination they should act in accordance with the instructions of the Supervisor and his
- 3. Under no circumstances whatsoever will a candidate be allowed into the Examination Hall after the lapse of half an hour after the commencement of a paper. No candidate will be permitted to leave the hall till after half an hour from the time of commencement of the paper. Candidates who come late for Practical and Oral Examinations are liable to be refused admission.
- 4. Every candidate should sit at the desk bearing his/her index number and not at any other desk. Unless with the permission of the supervisor no candidate should change his/her seat. The occupation of a seat other than the one assigned to him by a candidate is liable to be considered as an act with a dishonest intention.
- 5. Absolute silence should be maintained in the Examination Hall. A candidate is forbidden to speak to, communicate with or have dealings with any person within or outside the Examination Hall other than a member of the Examination Hall Staff. If there is an urgent need for a candidate to communicate with another, prior permission must be obtained from the supervisor.
- 6. A candidate's answer script is identified only by the Index Number and his/her name should not be written on the answer script. Another candidate's index number appearing on the answer script of a candidate is considered as an attempt to commit a dishonest act. Answer scripts bearing an index number that is difficult to decipher is liable to be rejected.
- 7. Candidates should write only on the paper provided and should not write anything on the blotting paper, question paper, desk or any other place. Non conformity with this rule could be taken as an act with dishonest intentions.
- 8. Any paper or answer book supplied should not be torn up, crushed, folded or erased. Each and every sheet of paper used for rough work should be tied up with the answer script. It should be a part of the answer script. (Such rough work should be neatly crossed out.) Anything written inside the Examination Hall should not be taken out. If a question has been answered twice, the unnecessary answer should be neatly crossed out. Failure to abide by these requirements may be considered as an attempt to cheat.
- 9. When answering questions in Mathematics the submission of correct answers with incorrect working or with no working at all and in art if the work of art is similar or very close in resemblance to that of another candidate in concept, in form or in execution it is liable to be considered as a dishonest act.
- 10. The removal of any paper or stationery supplied to candidates out of the Examination Hall is prohibited. All such material remains the property of the Commissioner of Examinations. Breach of this rule shall be liable
- to be considered an act with dishonest intention.

 11. While in the Examination Hall a candidate should not have with him or near him any book, note book, pocket note book, exercise book, sheet of paper or pieces of paper other than the stationery supplied to him. Nor should any handbag, travelling bag or parcel other than the candidate's boxes of colours and boxes of instruments where necessary or any file cover, card board pad, folded newspapers, brown papers should be brought into the Examination Hall. Breach of this rule is a punishable
- 12. A candidate is strictly forbidden to keep with him any book, note book or a sheet of paper with written notes once inside the Examination Hall. Should the Supervisor so requires, each candidate is bound to

declare everything he has with him/her. Breach of this requirement shall be considered as an attempt to commit an act of dishonesty.

- 13. Candidates are forbidden to copy or attempt to copy from the answer script of another candidate, a book, paper containing notes or any other source. A candidate should not attempt to look at the answer script of any another candidate. A candidate should refrain from helping another Candidate and also from getting help from another candidate or a person. Every completed answer sheet should be kept underneath the sheet on which the answer is being written. Sheets of writing paper should not be strewn all over the desk.
- 14. A candidate will under no circumstance whatsoever be allowed to leave the Examination Hall even for a brief period during the course of the paper. However in an emergency if a candidate needs to leave the hall, he/ she shall be allowed to do under the surveillance of the supervisor or his assistant. He/she shall be subject to search before leaving the hall as well as before re-entering it.
- 15. Impersonation while answering a paper or before the commencement of the Examination is a punishable offence. Tampering with identity cards, presenting false identity cards or tampering with someone's identity are also such offences. Candidates are warned not to commit such offences.
- 16. Assistance given to a candidate in a dishonest manner by a person who is not a candidate, is considered a serious offence.

Candidates should adhere to the following instructions for their own

safety:

- (i) Be at the Examination Hall well in time. It is sufficient to be at the Examination Hall 10 or 15 minutes before the commencement of each paper. If you have any doubt as to the location of the Examination Hall, make inquiries on a day prior to the date of Examination and be sure of its location.
- (ii) In case of any doubt regarding your entry for a paper or eligibility to sit a paper you should bring it to the notice of the Supervisor and get your doubts cleared. Failure to do so may result in your candidature for the subject being cancelled.
- (iii) When appearing for the Examination, candidates should produce their identity cards at every paper they sit. If a candidate fails to produce identification documents at the Examination Hall, his candidature is liable to be cancelled. In case a candidate forgets to bring such documents into the Examination Hall, it should be brought to the notice of the Supervisor and arrangements should be made to produce them before the Examination concludes.
- (iv) Standard stationery (i.e. writing paper, graph paper, ledger paper, precis paper) will be supplied. If you receive any stationery that is different from the kind generally distributed or distributed to the others it should be promptly brought to the notice of the supervisor. No paper other than those issued at the Examination Hall should be used for answering questions. Excess paper and other material should be left on the desk, in good condition. When log tables are supplied they should be used with care and left on the desk when you leave.

 (v) Candidates should bring their own pens, pencils, bottles of ink,
- erasers, pieces of cloth, rulers, geometrical instruments, coloured pencils, coloured chalk, etc.
- (vi) When you start answering you should promptly write down your Index Number and the name of the Examination on each sheet of paper used. Write neatly and legibly on both sides of the paper. Leave a blank line after the answer to each part of a question. After the answer to a full question leave one or several blank lines. Do not crowd in your work.
- (vii) The left-hand margin of the answer sheet is set apart for you to enter the number of the question you answer. The right hand margin is reserved for the examiner's use and nothing should be written there. Number your answers correctly as incorrect numbering leads to confusion.
- (viii) You should read carefully the instructions given at the head of the question paper, with regard to the compulsory questions and the manner in which the other questions should be selected. Disregard to these instructions is often liable to affect you adversely.
- When Mathematics Questions are answered, give all details of calculations and any roughwork, in their serial order as part of the working of the problem. Necessary sketches, diagrams and figures should be accurate and sufficiently large. In an answer running into serveral pages if reference must be made to a diagram drawn in an earlier page, that diagram should be drawn repeatedly.
- (x) At the end of each paper, arrange your answer sheets in the order you answered the questions. Then using the piece of twine supplied, tie them up at the top left hand corner. Do not tie up at the top right hand
- (xi) You should personally handover your answer script Supervisor or to an Invigilator. Or else remain in your seat till it is collected. Failure to do so may result in the loss of your script and your being treated as an absentee for the paper. On no account should your script be handed over to a peon or an attendant.

 (xii) If it becomes necessary for you to speak to the Supervisor or an

Invigilator, or if you need stationery, remain in your seat and raise your

 - 2.3.2 Clergy/those who bear a priesthood applying for the courses of Buddhism, Catholicism, Christianity should be not more than 30 years of age as on 01. 01. 2016;
- 2.4 Should be unmarried.

3.0 Basic Educational Qualifications.-

- 3.1 Should have passed three (03) subjects in one sitting at the G.C.E. (A/L) Examination held in Year 2014 (Estate workers' children with two (02) passes in one sitting are eligible to apply for Sri Pada National College of Education).

- 4.32.2 Should have passed in six (06) main subjects including Sinhala/ Tamil Language and Mathematics at G.C.E. (O/L) Examination.
- NOTE The applicants of this course will be considered to appoint as teachers of Special Educational needs such as visually- impaired, hearing-impaired, multiple impaired, autism, learning-difficulties and intellectual deficiencies. Hence, only the applicants, who are willing to sign an agreement to serve in these special units where the impaired children learn, should apply for this course.

The applicants in this course are accountable to serve the children of special needs. Therefore, the applicants who are not in appropriate physical and mental condition to assist such children are better refrain from applying to this course.

For Special Attention.-

The following points which will be relevant in the recruitment procedure in the year of 2017 and thereafter are published for the prior information of the applicants.

- ❖ Amendments of qualifications to recruit student teachers to follow above courses in National Colleges of Education after 2017 will be made in a par with the amendments to G.C.E. (A/L) curriculum in 2015 too.
- ❖ It has been suggested to consider one year Diploma Certificate issued by Buddhist and Pali University when selecting student teachers for the courses on Buddhism in National Colleges of Education in 2017, based on the results of G.C.E. (A/L) Examination held in 2015.
- It is expected to consider the Catholic Dhamma School Final Certificate issued by the Department of Examinations and the Certificate

- of three year Religious Studies Course conducted by Aquinas Higher Education Institute in addition to the qualifications stated under 4.8.2 of this *Gazette* notification for the selection of student teachers to follow Catholic/Christian courses in National Colleges of Education in **2017**, based on the results of G.C.E. (A/L) Examination held in **2015**.
- ❖ It has been suggested to consider passing of General Information Technology Examination (GIT) of Grade 12 and the National Vocational Qualification Certificate of Level Three (3) (NVQ) when selecting student teachers to follow Information Communication Technology Course in National Colleges of Education in 2018, based on the results of G.C.E. (A/L) Examination held in 2016.
- 5.0 Number of the Course, Name of the Course and the Medium in a par with the National Colleges of Education where each course will be conducted and the respective number of the NCoE are indicated below.

6.0 Procedure for Selection of Student Teachers for Year 2016

6.1 Basis of Selection:

6.1.1. The number of student teachers to be admitted to the Colleges has been decided by considering the teacher carder requirements based on the number of vacancies created through the retirement of teachers in the Year 2019, the existing number of vacancies at present in the school system and the necessity of making subject variations in the under-privileged areas and calculating the teacher requirement for

each subject and matching that number to the available facilities in 2016.

A higher percentage of student recruitment will be allocated for the courses of Primary Education, Science, Mathematics and English to the applicants from the underprivileged districts of Nuwara-eliya, Hambanthota, Jaffna, Kilinochchi, Mannar, Vavuniya, Mulaithivu, Batticaloa, Ampara, Trincomalee, Puttlam, Anuradhapura, Polonnuruwa, Badulla, Monaragala and Ratnapura (based on the number of student teachers selected for each course).

Although a large number of vacancies exists in the school system, the selection of student teachers to the National Colleges of Education will be made in accordance with the facilities available in each College.

- 6.1.1.1 Accordingly, the recruitment in 2016 will be made on two bases as mentioned below:
 - (i) If the number of applicants recruited is fifty (50) or less, the applicants with the highest qualification based on Z-Score will be selected from the twenty five (25) districts in the island or the districts where the subject is taught in the relevant medium.
 - (ii) If the number of applicants recruited is more than fifty (50), 50% of applicants will be selected on the basis of Secretarial Divisions and the remaining 50% will be selected on District basis. (If the number of applicants recruited for Sri Pada National College of Education is Fifty (50) or less for a particular course, the applicants with the highest qualifications and highest rank of Z-Score will be recruited from the Estate District. If the number of applicants recruited for Sri Pada National College of Education is more than fifty (50) for a particular course, 50% of the applicants will be selected on the basis of Secretarial Divisions in Estate districts and the remaining 50% will be selected on the
- 6.1.2 The basis of selection except for Catholicism/ Christianity (Sinhala Medium) course and Physical Education course will be the order of the Z-score obtained at G.C.E. (A/L) Examination in 2014 as stipulated in 6.1.1.1 in this *Gazette* notification.

Estate district basis).

When the selections are made on the basis of Z-score, if one student should be selected out of several students who have obtained the same Z-score in the relevant Secretarial Division or District/two or more applicants have scored the same mark in accordance with the 4.11.2 or 4.11.3/considering the Performance of Sports

- Marks if one student should be selected out of several who have scored the same mark, the results obtained at the G.C.E. (O/L) at the first sitting will be considered. Marks will be awarded as 04 marks for a Distinction pass, 03 marks for a Very Good pass, 02 marks for a Credit pass, and 01 mark for an Ordinary pass and the available number of vacancies will be filled based on the total marks obtained. The awarding of these marks will be limited only for eight (08) main subjects (as mentioned in 3.2). As mentioned in 4.11.2 or 4.11.3/ if marks of sports performance and G.C.E. (O/L) marks are the same, selection will be made on Z-Score as stipulated in 6.1.1.1
- 6.1.3 Applicants should reach a satisfactory level of performance at the Practical Test conducted for Physical Education, Dance (Oriental), Dance (Baratha), Music (Oriental), Music (Carnatic) and Western Music courses under the basis of recruitment stipulated in 6.1.1.1.
- 6.1.4
 - 6.1.4.1 If the expected number of qualified applicants is not available in each secretarial division, selections will be made considering the district performances or the provincial performances respectively.
 - 6.1.4.2 When the selections are made on district basis, if the required number of qualified applicants is not available, the provincial performance of the applicants will be considered.

6.2 Determination of Permanent Residence -

- 6.2.1 In the Secretarial Division based recruitment, the secretarial division of the applicant should be the secretarial division in which the applicant permanently resided in the year he/she appeared for the G.C.E. (A/L) Examination in the first sitting and the two years immediately preceding to that.
- 6.2.2 In the district basis, the applicant's district should be the district in which the applicant appeared for the G.C.E. (A/L) Examination in the first sitting and the two years immediately preceding to that.

- The province in which the applicant permanently resided in the year he/ she appeared for the G.C.E. (A/L) Examination in the first sitting and the two years immediately preceding to that will be considered as the province of the applicant in determining the provincial rank.
- Applicants should confirm their permanent residence by certified copies of electoral registers as per the procedure of recruitment.
- In case that the applicant fails to confirm their permanent residence of three years or several of the years by certified copies of electoral registers, acceptable reasons should be provided for being unable to register in the electorate in the 'Certificate on Residence and Character' issued by the Grama Niladhari (DS 04) under the column 'other information' with the signature of the Grama Niladhari of the division where the applicant's permanent residence is and counter signed by the Divisional Secretary.
- In case of the years of which the applicant was unable to register in the electoral register due to being underage, permanent residence of the applicant in such years should be confirmed by the copies of electoral registers in which the names of the applicant's parents appear.
- Applicants those who resided with a guardian other than the parents during the concerned period of time should confirm permanent residence by including such guardianship under the column 'other information' in the 'Certificate on Residence and Character' issued by the Grama Niladhari (DS 04). In case of the years of which the applicant was unable to register in the electoral register, permanent residence of the applicant in such years should be confirmed by certified copies of electoral registers in which the names of the applicant's guardian appear.
- In case that the applicant is able to confirm permanent residence only of one or two years, permanent residence of the remaining year/years should be confirmed by other acceptable

- documents (*e.g.* Certificate issued by the Grama Niladhari, Address in the National Identity Card issued by the Department of Registration of Persons).
- 6.2.3 For the applicants those who are unable to confirm permanent residence under 6.2.1/6.2.2 or Province, the Secretarial Division/District/Province in which the School/Examination Center the applicant appeared for the G.C.E. (A/L) Examination in the First sitting was located will be considered the Secretarial Division/District/Province of permanent residence of the applicant.

6.3 Selection for Sri Pada National College of Education

- 6.3.1 75% of the vacancies will be filled out of the applicants of the Indian Tamil Origin and 25% out of Sinhalese applicants.
 - 6.3.1.1 Based on the required number of vacancies prevailing in the secretarial divisions of the plantation districts/ those districts 35% of the candidates will be allocated to the secretarial divisions of Moneragala, Badulla and Ratnapura districts/those districts.

6.3.2

- 6.3.2.1 Applications for admission to Sri Pada National College of Education will be entertained only from the children whose parents are estate workers and residents in the Secretarial Divisions of the plantation districts; Nuwara Eliya, Kandy, Matale, Badulla, Moneragala, Ratnapura, Kegalle, Kalutara, Matara, Galle and Kurunegala/those plantation districts. Priority will be given to children of the workers who work at present and the children of estate workers living in estates after serving for at least 25 years in the estate sector and retired/ passed away/ left service on medical reasons during 2005 – 2014.
- 6.3.2.2 In case of insufficient number of applicants as per 6.3.2.1, applications from the children of the estate workers who worked continuously at least for 05, 04, 03 years after 2005 will be considered even if they are not employed at the moment. (Priority is given respectively as 2014, 2013, 2012.)

- 6.3.2.3 In case of insufficient number of applicants qualified in Tamil medium as mentioned above, applicants those who are not the children of employees in the plantation sector, but of Indian Origin living in secretarial divisions of the above mentioned districts/those districts, will be considered.
- 6.3.2.4 In case of insufficiency of qualified applicants under the above category too, Tamil Medium applicants with Indian Origin who are from other districts/ secretarial divisions of other districts will be considered.
- 6.3.2.5 Tamil Medium applicants with Indian Origin, living in secretarial divisions of plantation districts/plantation districts or Secretarial divisions of other districts/other districts should have passed in three subjects at G.C.E. (A/L) Examination.
- 6.3.2.6 In case of insufficient number of Sinhala Medium applicants from estate workers' children of plantation districts/ secretarial divisions of those districts, the rest of the vacancies will be filled out of those who have applied for the same course in Sri Pada/other National Colleges of Education. The basis of the selection will be the Z-Score.
- 6.3.3 At the interview, the children of the employees in the State and Private Sector Estate Companies should submit relevant documents out of the documents mentioned below to confirm that they are children of estate workers.
 - A letter from the Estate Superintendent relating to current service (with relevant time duration) that the parent is permanently and continuously serving and residing in estates.
 - A letter from the Estate Superintendent confirming the current permanent residence of the family members of estate workers those who have resigned from service due to medical reasons/ retired/passed away during 2005-2014 after serving in estate sector for 25 years.
 Permanent residence in the estate at

- present and the year and date of retirement/ resignation should be clearly mentioned in the letter.
- A letter from the Estate Superintendent confirming the continuous service for a period of past 05 years or more in plantation sector workers who retired/ resigned in or after 2005. (Indicating year and date clearly).
- Letters including Registration Numbers to prove that deductions are being made for the Employees' Provident Fund.
- 6.3.4 Applicants should submit an affidavit at the interview declaring to serve a period of ten (10) years continuously in the schools in the plantation sector after the course.
- Note In the case of an applicant having an Indian Tamil Origin who had studied in Sinhala Medium, they will be considered for the percentage entitled to Indian Tamil origin. Similarly, a Sinhalese applicant who had studied in Tamil Medium will be considered for the Sinhala Medium percentage.

7.0 Other matters related to selection

- 7.1 Selected applicants should be prepared to submit acceptable evidence and originals of certificates to confirm their eligibility on the date of interview. A number of applicants three times as the number of applicants to be recruited in each secretarial division/district will be called for the interview. Those who fail to appear in the interview without informing an acceptable reason on due date, are considered as absentees and their opportunity will be filled with other applicants from the same secretarial division/district based on the order of qualifications. Absentees will not be reconsidered.
- 7.2 It is mandatory to submit all original certificates at the Interview. Those who fail to do so will not be selected.
- 7.3 Mental and physical fitness required by an applicant for reaching the expected level in the Course and to enter the Teaching Profession will be checked by the Interview Board at the first interview following the criteria given by the Ministry of Education. The Interview

Board will submit their recommendations on whether the applicant possesses the required mental and physical fitness to enter the Teaching Profession.

- 7.4 Selected applicants according to section 7.3, will be notified through registered post. Accuracy of the submitted details will be reconfirmed by an interview board in the registration at the National College of Education. Those who fail to register at the relevant National Colleges of Education within 10 working days of the due date will be deprived of the opportunity for the admission. The vacancies created thereby, will be filled according to the performance order, subjected to the provisions stipulated in the recruitment procedure.
 - 7.4.1 Hence, it is emphasized that there is no any opportunity to consider appeals of the applicants who are not registered within said dates.
 - Specific situations for which an Interview Board is unable to submit recommendations will be directed to a Special Board. The report of the Special Board will be put forward to the Colleges of Education Board/Secretary to the Ministry of Education for the final decision.
- 7.5 Selected applicants through the first and second interviews are required to appear for a Medical Examination before their admission to the Colleges of Education for the certification of their health condition.
- 7.6 After the admission to any Course/National College of Education, permission will not be granted to change such Course/National College of Education. If a sufficient number of applicants are not available for a particular course, the applicants will be transferred to the nearest College of Education where the same course is in function.
- 7.7 The authority of the final decision regarding Cancellation of a course for which a required number of teacher vacancies does not exist, determination of the number of student teachers recruited and placement of courses in National Colleges of Education is held by

Colleges of Education Board/Secretary to the Ministry of Education.

8.0 Persons who are not eligible for applying or admission.

- 8.1 Those who have already obtained teaching appointments in Government Schools, Government Aided Schools, Government Registered Pirivena or other approved Institutions.
- 8.2 Those who have been selected for an appointment in a Government School.
- 8.3 Those who are following or who have followed a Course in a College of Education or those who have deserted a course in a National College of Education.
- 8.4 Those who are following or have registered for or followed a Professional Course/Higher Diploma under 'Free Education', registered as an internal student in a University or University Institute or any other Higher Education Institute where G.C.E. (A/L) is the entry requirement. (Students, who withdraw the registration after the *Gazette* Notification is published, will not be eligible for applying or admission.) Applicants who get registered and withdraw their registration of the above institutions after the *Gazette* Notification is published/appearing in the interview too will not be eligible for admission.
- 8.5 Student Teachers whose registration in a National College of Education has been terminated on disciplinary grounds.
- 8.6 Applicants those who are married or engaged to marry or divorced.

9.0 Conditions applicable for the course.

9.1 Duration of a Course is three years. This period consists of two year residential institutional training in the National College of Education and one year internship training attached to a school. Attendance of a student teacher should be not less than 90% to enable him/ her to sit for the External Final Examination conducted by the Department of Examinations at the end of the second year.

- 9.2 Every student teacher should pass in the Internal Continuous Assessments and the Internal Tests held in the first and the second year and the External Final Examination conducted by the Department of Examinations. Except those who follow English medium courses, all those who follow other courses should pass in the English subject at the above examinations.
- 9.3 During the period of two year residential course of study, a student teacher will be provided with meals and lodging facilities to the value of Rs. 3,500/ per month for ten (10) months in a year. During the Internship year, a monthly allowance of Rs. 4,000/- will be paid for ten (10) months. Other expenses for personal requirements should be borne by the student teacher.
- 9.4 Student teachers who register in a National College of Education should sign in a bond and agreement to the value of Five Hundred Thousand Rupees (Rs. 500,000.00) for the expenditure made by the government for the course of the applicant and the provision of other infra structure facilities. If the candidates give up the course within sixty (60) calendar days of registration at the National College of Education, they are allowed to do so after paying the sum spent by the government for the student teacher. If the candidates give up the course after sixty (60) calendar days of registration at the National College of Education, they should pay the whole sum mentioned in the bond and the agreement (Rs. 500, 000.00). Those who do not serve the government for five (05) years after successfully completing the course should pay the sum for the remaining period (counted in months) to complete 05 years. It is calculated as below;
 - Rs. <u>500, 000</u> × remaining number of 60 months months to complete
 - 9.4.1 If a candidate gives up the course due to special medical reasons during the training, the following documentary evidence should be submitted to prove the existing condition of the ailment.
 - Acceptable records of diagnosis, medical checkups and prescriptions.

 A letter of a government medical officer confirming the inability of the student teacher to continue the course of study further.

Management Board of the particular National College of Education will forward their observations recommendations after checking the above documents. Considering above recommendations, a board consisting of officials of the Ministry of Education and a board of medical officers will submit their recommendations for the approval the Colleges of Education Board/ Secretary to the Ministry of Education. With this approval, the student teacher will be permitted to resign from the course with no any payment.

- 9.4.2 No student teacher is permitted to go abroad during the course or the period till permanent appointment, except when duly resigned.
- 9.5 If a student teacher's registration is terminated on disciplinary grounds or being found out that he/she has submitted false information, the student teacher will be surcharged the whole amount incurred for him/her in the bond (Rs.500, 000.00).
- 9.6 During the period of course a student teacher will not be allowed to follow a course mentioned in section 8.4. If it is found out that a student teacher is following such a course, the sum of the Bond and Agreement (Rs.500, 000.00) incurred for him/her will be surcharged and the student teacher's registration will be terminated.
- 9.7 If the student teacher gets married/engaged to marry during the period of course or found out to be married/engaged to marry /divorced before the registration for the course, the studentship will be terminated. Those who get divorced giving various reasons after being found out to be married too will not be given studentship. If the clergy that are recruited under special provisions for those who hold priesthood are disrobed within the period of course the sum of the Bond and Agreement

(Rs.500, 000.00) incurred for him/her will be surcharged and the studentship will be terminated. The clergy of any religion should sign a Bond and Agreement with the Ministry of Education for at least 5 years' service without being disrobed. If disrobed for any reason, the amount for the remaining number of years (counted in months) should be paid to the government. It is calculated as below:

Rs. <u>5,00,000</u> × remaining number of 60 months months to complete

NOTE -

- If disrobed during the probation period, such clergy will be surcharged the relevant amount and dismissed.
 - 9.8 If a student teacher fails to exhibit the progress expected in his general conduct, enthusiasm and studies during the study course (inclusive of co-curricular activities), their studentship will be terminated. Likewise, studentship of those who do not reach a satisfactory level in the assessment during the first year of academic training will be terminated. Decision of the Colleges of Education Board/ Secretary to the Ministry of Education shall be final, regarding these matters.
 - 9.9 If any complaints are received in relation to the physical and mental fitness of the student teacher either by the President of the College during the course or by the Principal of the school during the Internship period the student teacher will be referred to a Special Interview Board. Final decision will be taken after the submission of that report to the Colleges of Education Board/ Secretary to the Ministry of Education
- 9.10 If the student teacher is proved to have engaged themselves in any action against the code of conduct of National Colleges of Education, Colleges of Education Board/Secretary to the Ministry of Education holds the authority of taking disciplinary action such as suspension to academic classes/extension of the course/termination of studentship/any other suitable punishment under the recommendation of the Disciplinary Board of the particular National College of Education.

- 9.11 Student teachers are not permitted to follow any other course during weekdays or at weekends outside the college.
- 9.12 If the teacher, for any reason, resigns or goes abroad within the first five years of service as a holder of National Diploma in Teaching, they should pay the amount for the remaining time (calculated in months) out of the whole amount mentioned in the bond and the agreement (Rs. 5,00,000) to the government. It is calculated as below:

Rs. <u>5,00,000</u> × remaining number of 60 months months to complete

NOTE -

- Those who resign during the first five years of service as mentioned in 9.12 will not be permitted to re-enter service as a holder of National Diploma in Teaching.
- Based on section 9.12, in addition to bond and the agreement, rules and regulations stipulated in Establishment Code are applicable to those who go abroad during the probation period of the teaching appointment.
- Those who expect to go abroad after the probation period, are allowed to do so enjoying the privileges of regular government servants, after paying the remaining sum as mentioned in section 9.12.
- 9.13 National Diploma in Teaching will be awarded to the student teachers who will successfully complete the Course. Course work and Personality Development (inclusive of compulsory co-curricular activities) will be continuously assessed during the period of course and this assessment will form a component of the final assessment in awarding the Diploma.
- 9.14 Applicants successfully completing this course will be given appointments as government teachers. They should agree to serve in any secretarial division/ district/ province of the island if there are no vacancies in the relevant secretarial division/district/ province though they have been recruited on secretarial division/district/provincial basis. Colleges of Education Board/Secretary to the Ministry holds the authority of placement.

- 9.14.1 The applicants who are called for interviews for recruitment should appear for the interview only if they agree to the above conditions.
- 9.14.2 Applicants who follow the course under the above conditions should teach the same subject that they are studying. In addition to that, after completing the National Diploma in Teaching, the applicants who are recruited on Secretarial Division/ District/Provincial Basis should sign a Bond and Agreement with the Secretary to the Ministry of Education stating that they will serve in the relevant Secretarial Division/District/ Province which they get their first appointment for a minimum period of five (05) years from the date of appointment as a condition of service. The Secretarial Division/District/ Province which the appointment has been given will not be changed for any reason within these five (05) years.
- 9.15 If any applicant claims to change the selected National College of Education on medical/ personal reasons, they will not be eligible for admission.
- 9.16 Any improper influence made to the relevant officials by the applicant himself/ herself or any other party related to the applicant during the recruitment procedure will be considered a disqualification in recruitment.
- 9.17 All educational and other qualifications should have been completed on or before the last date of calling for applications.

10.0 Applying:

Applications should be prepared with a good understanding of the number recruited for each course on Secretarial Division/District basis mentioned in chapters 7.0, 7.1 and 7.2 of 'Instruction to Prepare the Application'.

10.1 An applicant can apply for a maximum of three (03) Courses. If applied for the same course in two media, it is considered as applying for two courses. Such applicants can apply only for one more course. Those who are bearing priesthood in a religion should apply for the course pertaining to their religion only.

Example. A candidate applying for science course both in English and Sinhala media is
