1. General Qualifications required :

1:1 Every applicant must furnish satisfactory proof that he is a Sri Lankan. A “Sri Lankan” is a citizen of Sri Lanka by descent or by registration as defined in the Sri Lanka Citizenship Act.

1:2 A candidate for any post for which the minimum educational qualification prescribed is a pass in the Senior School Certificate Examination or equivalent or higher examination, should have a pass in the Senior School Certificate Examination or equivalent or higher examination, should have a pass either in Sinhala language or Tamil language obtained, as the case may be, at the Senior School Certificate Examination or its equivalent if he is either a Sinhalese educated in Sinhala Medium or if he is a Tamil educated in Tamil Medium (This requirement will not apply to those who are in the public service from a date prior to January 01, 1961, and who seek appointments to other posts in the public service).

1:3 Application from the “New Entrants” Public Officers, who are not either Sinhala or Tamil educated, whose probationary trial appointments have been terminated for failure to pass the prescribed official language proficiency tests will not be entertained unless they have obtained the qualifications which could entitle them to seek exemptions from the highest proficiency test prescribed for the post.

2. Conditions of Service-General :

2:1 All officers in the Public Service will be subject to the Financial Regulations, the Establishments Code, Departmental Orders or Regulations and any other Orders or Regulations that may be issued by the Governments from time to time.

2:2 A Public officer may be required to furnish security in terms of the Public Officers (Security) Ordinance, in such sum and in such manner as the secretary to the Ministry concerned may determine.

2:3 A Public Officer may be called upon to serve in any part of the Island.

3. Conditions of Service applicable to Public Officers holding permanent appointments :

3:1 In addition to the conditions referred to in Section 2 above Public Officer holding permanent appointments will be subject to the following further conditions:

3:1:1 All appointments will be on probation for a period of 3 years unless a longer period is considered necessary in respect of any post. Any appointment may be terminated at any time during the period of probation without a reason being assigned.

3:1:2 All public officers are required to conform to the provisions of the Chapter IV of the Constitution of the Democratic Socialist Republic of Sri Lanka and any other laws, regulations or rules that may be made from time to time to give effect to the Language Policy of the Government.

3:1:3 All Public officers who have not entered the Public Service either in Sinhala Medium or in Tamil Medium are required to acquire a working knowledge in one of the official languages.

3:1:4 Confirmation at the expiry of the period of probation of an officer who entered the Public Service in a medium other than Sinhala or Tamil will depend, inter alia, on the passing of the Grade I Proficiency Test in one of the Official Languages within one year; Grade II Proficiency Test within two years, and Grade III Proficiency Test (where applicable) within three years from the date of appointment.

Failure to pass a test within the prescribed period will result in the suspension of increments. Suspension will be converted to a stoppage if the test is not passed within a further period of six months beyond the prescribed period such stoppage operating until the test is passed or until such time as the provisions of Section 3:1:6 below apply.

3:1:5 Such officers should, on receiving appointment, be given facilities on full pay, for a period of 6 months to obtain proficiency in one of the official languages. He will thereafter, be required to sit the relevant proficiency examination and if he does not pass he will be given the opportunity to pass the examination within a period of 2 years immediately after the period of 6 months on full pay, while he performs his normal duties.

3:1:6 If he fails to pass the examination in this prescribed period of 2 1/2 years his services will be terminated.

3:1:7 A Public Officer already confirmed in permanent post in the Public Service will not normally be required to serve the period of probation on being appointed to another permanent post in the Public

Service. Such Officers may in the first instance be appointed to act in the new post for a specified period with a view to testing him in his new post.

3:1:8 Selected candidates (Other than those already holding permanent or temporary appointments in the Public Service) who have already been medically examined will be required to undergo a medical examination by a Government Medical Officer to test their physical fitness to serve in any part of the Island.

4. Terms of Engagement :

4:1 Public officers appointed to permanent and pensionable posts should contribute to the ‘Widows and Orphans’ Pension Scheme from their salary an amount equivalent to the percentage the Government requires to recover from their salary.

4:2 Public officers appointed to permanent or temporary posts on Provident Fund basis will be required to contribute 6% of their consolidated salary to the Public Service Provident Fund. The Government will contribute as its share of contributions an amount equal to 150% of the compulsory contributions credited to the fund at the close of the Financial Year.

4:3 Officers who hold pensionable appointments in the Public Service and who are released for appointments to pensionable posts in the Local Government Service and those officers in the Local Government Service who hold pensionable appointments and who are released for appointments to pensionable posts in the Public Service will be allowed pensionability in their posts in the Local Government Service and Public Service respectively.

4:4 Regular Force personnel in the Army, Navy and Air Force who are released for appointments to posts in the Public Service which are pensionable under the Minutes on Pension will be allowed pensionability in their posts in the Public Service. Notwithstanding anything to the contrary in these Minutes the unforfeited full pay service of any member of the Armed Forces who is released to accept an appointment as a Public Officer in a post which has been declared to be pensionable under these Minutes shall be reckoned for the purpose of any pension or gratuity payable under these Minutes.

5. Serving Officers in the Public Service :

5:1 Applications from officers of the Public Service who possess all the necessary qualifications must be forwarded through the Heads of their respective Departments. In the case of applications from Public Officers holding post in the permanent establishment in the Public Service. Heads of Departments in forwarding such applications should state whether the applicants could be released or not to take up the new appointment, if selected.

5:2 Candidates may be required to present themselves for interview at an appointed time and place. No travelling or other expenses will be paid in this connection.

5:3 Anyone desiring to recommend a candidate should do so by giving a testimonial. Any form of canvassing or any attempt to influence the selection of a candidate will disqualify such candidates.

5:4 Any statement in the application which is found to be incorrect will render the applicant liable to disqualification if the inaccuracy is discovered before the selection and to dismissal if discovered after the selection.

5:5 Application not conforming in every respect with the requirements of the advertisement will be rejected.

6. Definition of Salary for the purpose of Eligibility :

6:1 Salary for purposes of eligibility means only the consolidated salary and does not include any action salary, allowances etc.

7. New National Policy on Recruitment and Promotions :

Recruitment and Promotion in the Public Service, Provincial Public Service, Public Corporate Sector and Companies fully owned by the Government will be done in accordance with the policy laid down in the Public Administration Circulars No. 15/90 of 09.03.1990, 15/90 (I) of 25.03.1990 & 15/90 (ii) of 15.06.1990 with effect from 01.01.1990 subject to amendments that will be done by subsequent Public Administration Circulars.

Rules and Instructions for Candidates

“All candidates are bound to act in conformity with the provisions of the Examinations Act, No. 25 of 1968.”

All candidates are bound to abide by the rules given below. A candidate who violates any of these rules is liable to one or more of the following punishments at the discretion of the Commissioner of Examinations :—

- (i) Suspension from the whole or part of the examination or one subject or a part thereof ;
- (ii) Disqualification from one subject or from the whole examination ;
- (iii) Debarment from appearing for an examination for a period of one year or two years ;
- (iv) Debarment for life ;
- (v) Suspension of the certificate for a specified period ;
- (vi) Reporting the candidate's conduct to his Superiors or handing over the candidate to the Police or making a complaint to the Police over his action.

The Commissioner reserves himself the right to take action at any time before the Examination or at any stage of it or thereafter, and his decision shall be deemed final. In the case of examinations for recruitment to the Public Service, the decision of Commissioner of Examinations shall be subject to the Supervision of the Public Service Commission.

1. All candidates should conduct themselves in a quiet manner in and around the Examination Hall so as not to disturb or obstruct the Supervisor, his assistants or the other candidates. They should enter and leave the Examination Hall as quietly as possible.

2. Candidates should obey the Supervisor. Therefore, when the Examination is in progress and before the commencement of the Examination as well as immediately after the end of the Examination they should act in accordance with the instructions of the Supervisor and his assistants.

3. Under no circumstances whatsoever will a candidate be allowed into the Examination Hall after the lapse of half an hour after the commencement of a paper. No candidate will be permitted to leave the hall till after half an hour from the time of commencement of the paper. Candidates who come late for Practical and Oral Examinations are liable to be refused admission.

4. Every candidate should sit at the desk bearing his/her index number and not at any other desk. Unless with the permission of the supervisor no candidate should change his/her seat. The occupation of a seat other than the one assigned to him by a candidate is liable to be considered as an act with a dishonest intention.

5. Absolute silence should be maintained in the Examination Hall. A candidate is forbidden to speak to, communicate with or have dealings with any person within or outside the Examination Hall other than a member of the Examination Hall Staff. If there is an urgent need for a candidate to communicate with another, prior permission must be obtained from the supervisor.

6. A candidate's answer script is identified only by the Index Number and his/her name should not be written on the answer script. Another candidate's index number appearing on the answer script of a candidate is considered as an attempt to commit a dishonest act. Answer scripts bearing an index number that is difficult to decipher is liable to be rejected.

7. Candidates should write only on the paper provided and should not write anything on the blotting paper, question paper, desk or any other place. Non conformity with this rule could be taken as an act with dishonest intentions.

8. Any paper or answer book supplied should not be torn up, crushed, folded or erased. Each and every sheet of paper used for rough work should be tied up with the answer script. It should be a part of the answer script. (Such rough work should be neatly crossed out.) Anything written inside the Examination Hall should not be taken out. If a question has been answered twice, the unnecessary answer should be neatly crossed out. Failure to abide by these requirements may be considered as an attempt to cheat.

9. When answering questions in Mathematics the submission of correct answers with incorrect working or with no working at all and in art if the work of art is similar or very close in resemblance to that of another candidate in concept, in form or in execution it is liable to be considered as a dishonest act.

10. The removal of any paper or stationery supplied to candidates out of the Examination Hall is prohibited. All such material remains the property of the Commissioner of Examinations. Breach of this rule shall be liable to be considered an act with dishonest intention.

11. While in the Examination Hall a candidate should not have with him or near him any book, note book, pocket note book, exercise book, sheet of paper or pieces of paper other than the stationery supplied to him. Nor should any handbag, travelling bag or parcel other than the candidate's boxes of colours and boxes of instruments where necessary or any file cover, card board pad, folded newspapers, brown papers should be brought into the Examination Hall. Breach of this rule is a punishable act.

12. A candidate is strictly forbidden to keep with him any book, note book or a sheet of paper with written notes once inside the Examination Hall. Should the Supervisor so requires, each candidate is bound to

declare everything he has with him/her. Breach of this requirement shall be considered as an attempt to commit an act of dishonesty.

13. Candidates are forbidden to copy or attempt to copy from the answer script of another candidate, a book, paper containing notes or any other source. A candidate should not attempt to look at the answer script of any another candidate. A candidate should refrain from helping another Candidate and also from getting help from another candidate or a person. Every completed answer sheet should be kept underneath the sheet on which the answer is being written. Sheets of writing paper should not be strewn all over the desk.

14. A candidate will under no circumstance whatsoever be allowed to leave the Examination Hall even for a brief period during the course of the paper. However in an emergency if a candidate needs to leave the hall, he/she shall be allowed to do under the surveillance of the supervisor or his assistant. He/she shall be subject to search before leaving the hall as well as before re-entering it.

15. Impersonation while answering a paper or before the commencement of the Examination is a punishable offence. Tampering with identity cards, presenting false identity cards or tampering with someone's identity are also such offences. Candidates are warned not to commit such offences.

16. Assistance given to a candidate in a dishonest manner by a person who is not a candidate, is considered a serious offence.

Candidates should adhere to the following instructions for their own safety :—

(i) Be at the Examination Hall well in time. It is sufficient to be at the Examination Hall 10 or 15 minutes before the commencement of each paper. If you have any doubt as to the location of the Examination Hall, make inquiries on a day prior to the date of Examination and be sure of its location.

(ii) In case of any doubt regarding your entry for a paper or eligibility to sit a paper you should bring it to the notice of the Supervisor and get your doubts cleared. Failure to do so may result in your candidature for the subject being cancelled.

(iii) When appearing for the Examination, candidates should produce their identity cards at every paper they sit. If a candidate fails to produce identification documents at the Examination Hall, his candidature is liable to be cancelled. In case a candidate forgets to bring such documents into the Examination Hall, it should be brought to the notice of the Supervisor and arrangements should be made to produce them before the Examination concludes.

(iv) Standard stationery (i.e. writing paper, graph paper, ledger paper, precis paper) will be supplied. If you receive any stationery that is different from the kind generally distributed or distributed to the others it should be promptly brought to the notice of the supervisor. No paper other than those issued at the Examination Hall should be used for answering questions. Excess paper and other material should be left on the desk, in good condition. When log tables are supplied they should be used with care and left on the desk when you leave.

(v) Candidates should bring their own pens, pencils, bottles of ink, erasers, pieces of cloth, rulers, geometrical instruments, coloured pencils, coloured chalk, etc.

(vi) When you start answering you should promptly write down your Index Number and the name of the Examination on each sheet of paper used. Write neatly and legibly on both sides of the paper. Leave a blank line after the answer to each part of a question. After the answer to a full question leave one or several blank lines. Do not crowd in your work.

(vii) The left-hand margin of the answer sheet is set apart for you to enter the number of the question you answer. The right hand margin is reserved for the examiner's use and nothing should be written there. Number your answers correctly as incorrect numbering leads to confusion.

(viii) You should read carefully the instructions given at the head of the question paper, with regard to the compulsory questions and the manner in which the other questions should be selected. Disregard to these instructions is often liable to affect you adversely.

(ix) When Mathematics Questions are answered, give all details of calculations and any roughwork, in their serial order as part of the working of the problem. Necessary sketches, diagrams and figures should be accurate and sufficiently large. In an answer running into several pages if reference must be made to a diagram drawn in an earlier page, that diagram should be drawn repeatedly.

(x) At the end of each paper, arrange your answer sheets in the order you answered the questions. Then using the piece of twine supplied, tie them up at the top left hand corner. Do not tie up at the top right hand corner.

(xi) You should personally handover your answer script to the Supervisor or to an Invigilator. Or else remain in your seat till it is collected. Failure to do so may result in the loss of your script and your being treated as an absentee for the paper. On no account should your script be handed over to a peon or an attendant.

(xii) If it becomes necessary for you to speak to the Supervisor or an Invigilator, or if you need stationery, remain in your seat and raise your hand.

Note.– Complaints made on the loss or delay of applications and other related letters in the post will not be considered. The damages caused due to delay in the application until the closing date shall be borne by the applicant.

1. **Method of Recruitment.**– Recruitment will be made on the basis of result of the structured interview.

2. **Condition of Service :**

- (i) This post permanent. You are subjected to policy decisions taken by the government on Scheme of Pension entitled to you.
- (ii) Officers appointed to this post are subjected to three (03) years probationary period and Efficiency Bar Examination shall be passed within 03 years.
- (iii) In terms of the Public Administration Circular No. 1/2014 dated January 21, 2014, Officer shall obtain the State Language Proficiency within five (05) years of appointment to the post and officers who have been recruited from a language other than a state language, shall pass relevant Language Proficiency within the probationary period.

- Darga Town National College of Education is reserved only for Tamil medium females.

6.0 Procedure for Selection of Student Teachers for Year 2017

6.1. Basis of Selection:

6.1.1. The number of student teachers to be recruited to the Colleges has been decided by considering the teacher carder requirements based on the number of vacancies that will be created through the retirement of teachers in the Year 2020 and the existing number of vacancies at present in the school system; the necessity of making subject variation in the under-privileged areas; and calculating the teacher requirement for each subject and matching that number to the available facilities for each course in National Colleges of Education in 2017.

A higher percentage of total student recruitment to the courses of Primary Education, Science, Mathematics, and English will be allocated for the under-privileged districts of Nuwara-eliya, Hambanthota, Jaffna, Kilinochchi, Mannar, Vavuniya, Mulaithiv, Batticaloa, Ampara, Trincomalee, Puttlam, Anuradhapura, Polonnaruwa, Badulla, Monaragala and Ratnapura.

The major factor that determines the number of student teachers recruited to the National Colleges of Education is the availability of facilities for each course.

6.1.1.1 Accordingly, the recruitments in 2017 will be made as follows.

- (i) In relation to each course, the applicants with the highest qualification based on Z-Score will be selected from the twenty-five (25) districts in the island or the districts where the subject is taught in the relevant medium.
- (ii) When applicants are selected to Sripada National College of Education, the applicants with the highest qualifications and the highest rank of Z-Score will be recruited from the Estate Districts.

6.1.2 The basis of selection except for Catholicism/ Christianity course and Physical Education course will be the order of the Z-score obtained at G.C.E. (A/L) Examination as stipulated in 6.1.1.1.

When the selections are made on the basis of Z-score, if one student should be selected out of several students who have obtained the same Z-score in the relevant District / if one student should be selected out of several who have scored the same mark considering the Performance of Sports Marks, the results obtained at the G.C.E. (O/L) at the first sitting will be considered.

Accordingly, marks will be awarded as 04 marks for a Distinction, 03 marks for a Very Good pass, 02 marks for a Credit pass, and 01 mark for an Ordinary pass and selection will be made based on the total marks obtained. The awarding of these marks will be limited only for six (06) core subjects (as mentioned in 3.2). (Category subjects and optional subjects are not considered.)

6.1.3 Applicants should prove proficiency in the subject concerned at the Practical Test conducted for Physical Education, Dance (Oriental), Dance (Baratha), Music (Oriental), Music (Carnatic) and Western Music courses.

6.1.4. When the selections are made on district basis, if the required number of qualified applicants is not available, the provincial/ national level performance of the applicants will be considered.

6.2. Determining the Permanent Residence –

6.1.1 When the selections are made on district basis, the applicant's District should be the District in which the applicant was permanently resident in the year when he/she appeared for the G.C.E. (A/L) Examination in the first sitting and the two years immediately preceding to that.

The province in which the applicant was permanently resident in the year he/she appeared for the G.C.E. (A/L) Examination in the first sitting and the two years immediately preceding to that will be considered as the province of the applicant in determining the provincial rank.

1. Applicants should confirm their permanent residence by certified

copies of electoral registers as per the procedure of recruitment.

2. In case that the applicant fails to confirm their permanent residence of three (03) years or several of the years by certified copies of electoral registers, acceptable reasons should be provided for being unable to register in the electorate in the 'Certificate on Residence and Character' issued by the Grama Niladhari (DS 04) under the column 'Other Information' with the signature of the Grama Niladhari of the division where the applicant's permanent residence is and counter signed by the Divisional Secretary.
3. In case of the years of which the applicant was unable to register in the electoral register due to being underage, permanent residence of the applicant in such years should be confirmed by the copies of electoral registers in which the names of the applicant's parents appear.
4. Applicants who were resident with a guardian other than the parents during the concerned period of time should confirm permanent residence by mentioning such guardianship under the column 'Other Information' in the 'Certificate on Residence and Character' issued by the Grama Niladhari (DS 04). In case of the years of which the applicant was unable to register in the electoral register, permanent residence of the applicant in such years should be confirmed by certified copies of electoral registers in which the name of the applicant's guardian appears.
5. In case that the applicant submits certified copies of electoral registers only for one or two years, permanent residence of the remaining year/ years should be confirmed by other acceptable documents (e.g. Certificate issued by the Grama Niladhari, Address in the National Identity Card issued by the Department of Registration of Persons)

6.3 Selection for Sripada National College of Education

- 6.3.1 75% of the vacancies will be filled out of the applicants of the Indian Tamil Origin and 25% out of Sinhalese applicants. (Applicant should be able to directly or indirectly prove their Indian Tamil Origin).
- 6.3.2 The number of applicants to be recruited will be distributed among estate districts based on the available vacancies in those districts.
- 6.3.3 Only the children whose parents are estate workers and residents of the plantation districts – Nuwara Eliya, Kandy, Matale, Badulla, Moneragala, Ratnapura, Kegalle, Kalutara, Matara, Galle and Kurunegala and Colombo should apply for Sripada National College of Education.
- 6.3.4 Priority will be given to children of the workers who work at present and the children of estate workers living in estates after serving for at least 10 years in the estate sector, retired, passed away, left service on medical reasons during 2006 - 2015.
- 6.3.5 In case of insufficient number of applicants as per 6.3.3, applications from the children of the estate workers who worked continuously at least for 05, 04, 03 years after 2005, will be considered even if they are not employed at the moment. (Priority is given respectively as 2014, 2013, 2012).
- 6.3.6 In case of insufficient number of applicants qualified for Tamil medium courses as mentioned above, applicants those who are not the children of employees in the plantation sector, but of Indian Tamil Origin living in the above mentioned districts, will be considered.
- 6.3.7. In case of insufficiency of qualified applicants under the above category too, Tamil Medium applicants with Indian Tamil Origin who are residents of other districts will be considered.

6.3.8. In case of insufficient number of applicants for Sinhala Medium courses from estate workers' children of Plantation Districts, the rest of the vacancies will be filled out of those who have applied for the same course in Sripada/ Other National Colleges of Education. The basis of the selection will be the Z-Score.

6.3.9. At the interview, the children of the employees in the State and Registered Private Sector Estate Companies should submit relevant documents out of the documents mentioned below to confirm that they are children of estate workers :

- Those who are employed in estates should submit a letter certified by the Estate Superintendent to prove the uninterrupted service (with relevant time duration) and permanent residence in the relevant estates.
- The letter issued by the Estate Superintendent confirming the current permanent residence of the family members of estate workers who have resigned from service due to medical reasons/retired/passed away during 2006-2015 after serving in estate sector for 10 years. Permanent residence in the estate at present and the year and date of retirement/resignation should be clearly mentioned in the letter together with Grama Niladhari Certificate.
- The letter issued by Estate Superintendent confirming the continuous service for a period of past 05 years or more in the plantation sector. This is relevant to the workers who retired/resigned in or after 2006. The year and date of retirement or resignation should be mentioned clearly.
- The letter indicating Registration Numbers to prove that deductions are being made for the Employees' Provident Fund; or Grama Niladhari Certificate confirming the residence in estates.

6.3.10. It is compulsory that the applicants submit an affidavit at the interview

declaring to serve a period of ten (10) years continuously in the schools in the plantation sector after the training.

6.4. Note :

6.4.1. In the case of an applicant having an Indian Origin who has studied in Sinhala Medium, they will be considered for the percentage entitled to Indian origin. Similarly, a Sinhalese applicant who has studied in Tamil Medium will be considered for the Sinhala Medium percentage.

6.4.2. The estate sector workers' children who apply for the courses conducted in Sripada National College of Education may apply for other courses if they have acquired the relevant qualifications.

7.0 Other matters related to selection

7.1 Selected applicants should be prepared to submit acceptable evidence and originals of certificates to confirm their eligibility on the date of interview. A number of applicants three times as the number of vacancies in each district will be called for the interview. Those who fail to appear for the interview without any prior notice on due date, are considered as absentees and their opportunity will be filled with other applicants from the same district based on the order of qualifications. Absentees will not be reconsidered.

7.2 It is mandatory to submit the originals of all certificates at the Interview. Those who fail to do so will not be selected.

7.3 Mental and physical fitness required by an applicant for reaching the expected level in the Course and to enter the Teaching Profession will be checked by the Interview Board at the first interview following the criteria given by the Ministry of Education. The Interview Board will submit their recommendations on whether the applicant possesses the required mental and physical fitness to enter the Teaching Profession.

7.4 Applicants Selected according to Section 7.3, will be notified through Registered Post. Accuracy of the submitted details will be reconfirmed by an interview board at the registration in the relevant National College of Education. Those who fail to register at the relevant National Colleges of

Education within ten (10) working days of the due date will be deprived of the opportunity for the admission. The vacancies created thereby, will be filled according to the performance order, subjected to the provisions stipulated in the recruitment procedure.

7.4.1 Hence, it is emphasized that there is no opportunity to consider appeals of the applicants who are not registered on due date.

- Specific situations for which an Interview Board is unable to submit recommendations in accordance with 7.3 and 7.4 above will be directed to a Special Committee. The report of the Special Committee will be forwarded to the Colleges of Education Board/ Secretary to the Ministry of Education for the final decision.

7.5. Applicants selected through the first and second interviews are required to appear for a Medical Examination before their admission to the Colleges of Education for the certification of their physical and mental fitness.

7.6. After the applicant is selected to a Course/ National College of Education, permission will not be granted to change such Course/ National College of Education.

7.7. If a sufficient number of applicants are not available for a particular course, the applicants will be transferred to the nearest College of Education where the same course is conducted.

7.8. The authority of the final decision regarding Cancellation of a course for which a sufficient teacher requirement does not exist, determination of the number of student teachers recruited and placement of courses in National Colleges of Education is held by Colleges of Education Board/Secretary to the Ministry of Education.

8.0 Persons who are not eligible for applying for the courses or admission:

8.1 Those who have already obtained teaching appointments in government schools, government aided schools, government registered Pirivena or other approved institutions.

8.2 Those who have been selected for an appointment in a Government School.

8.3 Those who are following or who have followed a Course in a College of Education or those who have deserted a course in a National College of Education.

8.4 Those who are following / have registered for / followed a Degree Course / a Professional Training Course/Higher Diploma under 'Government Free Education Benefits', registered as an internal student in a University / University Institute / any other Higher Education Institute where G.C.E. (A/L) is the entry requirement. (Students, who withdraw the registration of above institutions after the *Gazette* notification is published, will not be eligible for applying or admission.) Applicants who withdraw their registration of the above institutions after the *Gazette* notification is published/ appearing for the interview too will not be eligible for admission.

8.5 Student Teachers whose registration in a National College of Education has been terminated on disciplinary grounds.

8.6 Applicants those who are married, engaged to marry or divorced.

9.0 Conditions applicable for the course

9.1 Duration of the Course is three years. This period consists of two-year residential institutional training in the National College of Education and one-year internship training attached to a school. Attendance of a student teacher should be not less than 90% for him/ her to be eligible to sit for the External Final Examination conducted by the Department of Examinations at the end of the second year.

9.2 Every student teacher should pass in the Internal Continuous Assessments and the Internal Tests held in the first and the second year and the external final examination conducted by the Department of Examinations. Except those who follow English medium courses, all those who follow other courses should pass in the English subject at the above examinations.

9.3 During the period of two-year residential training, a student teacher will be provided with meals and lodging facilities to the value of Rs.5,000 per month for ten (10) months in a year.

During the Internship year, a monthly allowance of Rs. 5,000 will be paid for ten (10) months. Other expenses for personal requirements should be borne by the student teacher.

- 9.4 Student teachers who register in a National College of Education should sign in a bond and agreement to the value of Five Hundred Thousand Rupees (Rs. 500, 000.00) for the expenditure made by the government for the training of the applicant and the provision of other infrastructure facilities. If the student teacher gives up the course within 60 calendar days of registration at the National College of Education, they are allowed to do so after paying the sum spent by the government for the student teacher. If the student teacher gives up the course after 60 calendar days of registration at the National College of Education, they should pay the whole sum mentioned in the bond and the agreement (Rs. 500,000). If a student teacher fails to attend the academic activities for not less than one month without formal notification, she/he is considered vacated the course and will be dismissed from the course after the whole sum of Rs. 500,000 mentioned in the bond and agreement is surcharged.

Those who do not accept the appointment to a government school after successful completion of the course will be dismissed after surcharging the whole sum mentioned in the bond and the agreement (Rs. 500,000). In addition, those who do not serve the government for 05 years after successfully completing the course and accepting appointment to a government school, should pay the sum for the remaining number of years (counted in months) to complete 05 years. It is calculated as below;

$$\frac{\text{Rs. 500, 000}}{60 \text{ months}} \times \frac{\text{remaining number of months}}{\text{to complete}}$$

- 9.4.1. If a student teacher leaves the course due to special medical reasons during the training, the following documentary evidence should be submitted to prove the existing condition of the ailment.
- Acceptable records of diagnosis, medical checkups and prescriptions.
 - A letter of a government medical officer confirming the inability of the student teacher to continue the course of study further.

Management Board of the particular National College of Education will forward their observations and recommendations after checking the above documents. Considering the above recommendations, a board consisting of officials of the Ministry of Education and a board of medical officers or a government medical officer nominated by Ministry of Health will submit the recommendations for the approval of the Colleges of Education Board/ Secretary to the Ministry of Education. With this approval, the student teacher will be permitted to resign from the course with no payment.

- 9.4.2 No student teacher is permitted to go abroad during the period the course is conducted or the period until permanent appointment is given, except when duly resigned.
- 9.5 If a student teacher's registration is terminated on disciplinary grounds or being found that he/she has submitted false information or harboured the true information in relation the paragraph **"Persons who are not eligible for applying for the courses or admission"** of clause 8.0, such student teachers will be surcharged the whole amount incurred for him/her in the bond (Rs.500,000) before the discontinuation.
- 9.6 Under any circumstances a student teacher will not be allowed to follow a course mentioned in section 8.4 during training period. If it is found that a student teacher is following such a course, the sum of the Bond and Agreement (Rs.500,000) incurred for him/her will be surcharged and the student teacher's registration will be terminated.
- 9.7 If the student teacher gets married/engaged to marry during the training period or found to be married/engaged to marry before the registration for the course, the studentship will be terminated. Those who get divorced giving various reasons after being found to be married during period of the course or before that too will not be given studentship.
- 9.8 If the clergy/ those who bear priesthood that are recruited under special provisions are disrobed after registration, the sum of the Bond and Agreement (Rs. 500,000) incurred for him/her

will be surcharged and the studentship will be terminated. The clergy of any religion should sign a Bond and Agreement with the Ministry of Education for service of at least 5 years without being disrobed. If disrobed for any reason without completing the said 5 year, the amount for the remaining number of years (counted in months) should be paid to the government. It is calculated as below;

$$\frac{\text{Rs. 500,000}}{60 \text{ months}} \times \frac{\text{remaining number of months}}{\text{to complete}}$$

- If disrobed during the probation period, such clergy will be surcharged the relevant amount and dismissed.

9.9 If a student teacher fails to exhibit the progress expected in his general conduct, attendance, enthusiasm and studies during the study course (including co-curricular activities), their studentship will be terminated. Likewise, studentship of those who do not reach a satisfactory level in the assessment during the first year of academic training will be terminated. Decision of the Colleges of Education Board/Secretary to the Ministry of Education shall be the final, regarding these matters.

9.10 If any complaints are received in relation to the physical and mental fitness of the student teacher either by the President of the College during the period of course or by the Principal of the school during the Internship period, the trainee will be referred to a Special Interview Board. Final decision will be taken after the submission of that report to the Colleges of Education Board/Secretary to the Ministry of Education.

9.11 If the student teacher is proved to have engaged themselves in any action against the code of conduct of National Colleges of Education during the course, Colleges of Education Board/Secretary to the Ministry of Education holds the authority of taking disciplinary action such as suspension to academic classes to a period of time /extension of the course/ termination of studentship/any other suitable punishment under the recommendation of the Disciplinary Board of the particular National College of Education.

9.12 Student teachers are not permitted at all to go out of college to follow any other course during weekdays or at weekends.

9.13 If the teacher, for any reason, resigns or goes abroad within the first five years of service as a holder of National Diploma in Teaching, they should pay the amount for the remaining time (calculated in months) out of the whole amount mentioned in the bond and the agreement (Rs. 500,000) to the government. It is calculated as below;

$$\frac{\text{Rs. 500,000}}{60 \text{ months}} \times \frac{\text{remaining number of months}}{\text{to complete}}$$

Note:

- Those who resign during the first five years of service as mentioned in 9.13 will not be permitted to re-enter service as a holder of National Diploma in Teaching.
- Based on section 9.13, in addition to the agreement, rules and regulations stipulated in Establishment Code are applicable to those who go abroad during the probation period after getting a teaching appointment.
- Those who expect to go abroad after the probation period, are allowed to do so enjoying the privileges of regular government servants, after paying the remaining sum as mentioned in section 9.13. (Circular No. 24/2017)

9.14 National Diploma in Teaching will be awarded to the student teachers who will successfully complete the Course. Course work and Personality Development (inclusive of compulsory co-curricular activities) will be continuously assessed during the period of course and this assessment will form a component of the final assessment in awarding the Diploma.

9.15 Applicants successfully completing this course will be given appointments as teachers in Government schools. They should agree to serve in any District/Province of the island if there are no vacancies in the relevant District/Province in placement, though they have been recruited on District/Provincial basis. Colleges of Education Board/Secretary to the Ministry takes the final decision of placement.

- 9.15.1 The applicants who are called for interviews should appear for the interview only if they agree to the above conditions.
- 9.15.2 Applicants who receive their training under the above conditions should teach the same subject that they followed. In addition to that, after completing the National Diploma in Teaching, the applicants who are recruited on District/Provincial basis should sign a Bond and Agreement with the Secretary to the Ministry of Education stating that they will serve in the relevant District/Province which they get their first appointment for a minimum period of five (05) years from the date of appointment as a condition of service. The District/Province which the appointment has been given will not be changed for any reason within these five (05) years.
- 9.16 If any applicant claims to change the National College of Education to which the applicant is recruited by the Ministry of Education on medical/ personal reasons, they will not be eligible for admission.
- 9.17 Any improper influence made to the relevant officials by the applicant him/herself or any other party related to the applicant during the recruitment procedure will be considered a disqualification in recruitment.
- 9.18 All educational and other qualifications should have been completed on or before the last date (24.11.2017) of calling for applications.

10.0 Applying :

Applications should be prepared with a good understanding of the number recruited for each course on district basis mentioned in para 7.0 and 7.1 of chapter ‘Instruction to Prepare the Application’.

- 10.1 An applicant can apply for a maximum of three (03) Courses. If applied for the same course in two media, it is considered as applying for two courses. Such applicants can apply only for one more course. Those who are bearing priesthood in a religion should apply for the course pertaining to their religion only.

Example: A candidate applying for science course both in English and Sinhala media is considered to have applied for two courses. Therefore, he/she can apply only for one more course.

- 10.2 An Applicant may submit only one application. If any applicant has submitted more than one application, all the applications will be rejected.
- 10.3 Only the applicants who apply for Buddhism, Hinduism, Islam, Catholicism / Christianity, Physical Education, Western Music must enclose two (02) certified photocopies of the application in the same envelope.
- 10.4 Application should be prepared according to the specimen form and instructions given below.
- 10.5 Applications should be sent through registered post, addressed to Chief Commissioner (Teacher Education), National Colleges of Education Branch, Ministry of Education, Isurupaya, Battaramulla to be received on or before **24.11.2017**

Specimen of the envelope in which the application should be enclosed is as follows:

(It is emphasized that applications should not be sent to Department of Examinations or National Colleges of Education)

- 10.6. It is compulsory to keep a photocopy of the completed application with the applicant. It is compulsory to forward the photocopy of the application in the interview for the recruitment to National Colleges of Education. **The postal receipt of registration issued and a photocopy of the application** should be submitted in all instances of making inquiries or submitting appeals.
- 10.7. **Applications which do not clearly indicate the Index Number, Year, Number and the Name of the Course as well as the incomplete and informal applications will be rejected.**
- 10.8. Ministry of Education will not be responsible for the inconveniences faced by the applicants who apply without fulfilling the qualifications mentioned in the *Gazette* Notification for the courses.
- 10.9. Receipt or rejection of applications will not be acknowledged. Applying for a course/being called for an interview is not a qualification for recruitment. Recruitment is made only by considering the vacancies and the requirements of the District. National Colleges of Education Board/Secretary to the Ministry of Education holds the authority of final decision regarding this.
- 10.10. No other document should be attached to the application except when specifically mentioned.
- 10.11. If any certificate submitted by the applicant is revealed later to be forged or fraudulent, the applicant's studentship will be terminated. If in any case, they will be dismissed and will further be ineligible for any post in Public Service.
- 11.0 Regarding any problems or specific situations arising with regard to the above information in this *Gazette* Notification, the decision of the Colleges of Education Board/ Secretary to the Ministry of Education will be the final.
- 12.0. In the event of any inconsistency between Sinhala and Tamil or English Texts of this *Gazette* Notification, the Sinhala Text shall prevail.
