Should have taken oaths as an Attorney - at - Law of the Supreme Court of Sri Lanka after obtaining a Degree in Law from a University recognized by the University Grants Commission or Taken oaths as an Attorney - at - Law of the Supreme Court of Sri Lanka after passing the Final Examination of the Sri Lanka Law College.

(B) *Experience :-*

Professional and active experience of not less than 03 years as an Attorney - at - Law of the Supreme Court of Sri Lanka.

(C) *Physical Qualifications :-*

Every applicant should be physically and mentally fit to serve in any part of the North Western Province and to perform duties of the post.

(D) *Other Qualifications :-*

- I. Should be a citizen of Sri Lanka and a resident of the territory of the North Western Provincial Council during preceding five years (5) to the closing date of applications.
- II. Applicants should have an excellent moral character and they should be in good health condition.
- III. All requirement for recruitment should be completed to the date 03.04.2017, and the certificates should have obtained on or before that date.
- IV. Age should be not less than 25 years and not more than 35 years as at 03.04.2017.

04. *Conditions of Service :-*

- I. This post is permanent. The appointees will be subjected to the policy decision taken by the government on the Pension Scheme applicable to the appointees.
- II. The appointees to this post will be subjected to a probation period of three (03) years. The appointment will be made permanent at the end of the probation period only if the service and conduct of the respective appointee is satisfactory and if the first efficiency bar requirement and other requirements for making the appointment permanent have been fulfilled.
