All Notices to be published in the weekly *Gazettes* should reach Government Press two weeks before the date of publication *i.e.* Notices for publication in the weekly *Gazette* of 06th October 2017 should reach Government Press on or before 12.00 noon on 22nd September, 2017.

NOTIFICATION MADE UNDER STATE LAND REGULATION No. 21 (2)

IT is hereby notified that for the purpose of Dai - Ichi Ceylon (Pvt) Ltd has requested on lease a State land containing in extent about 01 Arc in the Tracing Plan drawn by the colonization office situated in the village of Sannasi with belongs to the Grama Niladhari Division of 223 Parandan coming within the area of authority of Vauniya Divisional Secretariat in the District of Vauniya.

02. Given below are the boundaries of the land requested :

On the North by: Gnanakannan Gnanprakasam ;

On the East by : State Land ;

On the South by: State Land ;

On the West by : Road.

The land requested can be given on lease for the necessary purpose. Therefore, the Government has intended to lease out the land subject to other Government approved conditions : -

(a) *Terms of the Lease.*— Thirty Years (30) , (From 17.08.2017 Onwards);

The Annual Rent of the Lease.— In the instances where the assessed value of the land in the year 2017 is less than five million rupees (Rs. 5,000,000) 2% of the market value of the land in the said year, as per the valuation of the chief valuer. In the instances where the assessed value of the land in the effective year of the lease in the more than five million rupees (Rs. 5,000,000) 4% of the market value of the land in the said year as a per valuation of the chef valuer. The amount of the lease must be revised in the every five years and the revision shall add 20% to the amount that just preceded.

Premium .- Not levied ;

- (b) The lessee must, within one year of the commencement of the lease, develop the said land, in such a manner as to captivate the mind of the Divisional Secretary ;
- (c) The lessee must not use this land for any purposes other than for the purpose of Commercial purpose ;
- (d) This lease must also be subject to the other special conditions stipulated and imposed by the Divisional Secretary/Scoping Committee/Board of Investment of Sri Lanka and by other institutions;
- (e) The buildings constructed and construction must be maintained in a proper state of repair.
- (f) Once the land is given on lease and in the event of failure on the part of the lessees to substantiate within the specified time frame the purpose for which the land was obtained, action will be taken to terminate the lease ;
- (g) No sub - leasing can be done until the expiry of a minimum period of 05 years;
- (h) Payment of the lease must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse.

If acceptable reasons are not submitted to me in writing within six weeks of the date which this Notice is Published in the Gazette to the effect that this land must not be given on lease, the land will be leased out as requested.
