The notice must state the name and address of the person, or, if a firm, the name and address of the firm and must be Signed by the Person or firm, or his or their Attorney -at-Law (if any) and must be served, or if posted, must be sent by post in sufficient time to reach the above named no later than 6.00 o' clock in the afternoon of the 07th January, 2019.
