NOTIFICATION MADE UNDER STATE LAND REGULATION No. 21 (2)

IT is hereby notified that for the Commercial purpose, The Ceylon Electricity Board has requested on lease a State Land containing in extent about 0.0455 Hect. out of extent marked Lot No. 04 as depicted in Plan No. . P. P. 4211 and situated in the village of Dadalla which is belongs to the Grama Niladhari Division of No. 102, Dadalla (East) coming within the area of authority of Galle Four Gravest Divisional Secretariat in the District of Galle.

01. Given below are the boundaries of the land requested.

The land requested can be given on lease for the necessary purpose. Therefore, the Government has intended to lease out the land subject to other Government approved conditions and the following conditions.

(a) *Term of the lease.*- Thirty years (30) (From 27.08.2018 Onwards)

The annual rent of the lease.- 2% of the prevailing market value of the Land, on occasions when the assessed value of the land as per the valuation of the Chied Valuer for that year is lower than Rupees Five Million (Rs. 5,000,000) 4% of the prevailing market value of the land on assessed year is higher than Rupees Five Million (Rs. 5,000,000). This amount of the lease must be revised once in all five years and 20% should be added to the final annual rental of the previous 5 years.

- (b) The lessees must, not use this land for any purpose other than for the purpose of capacity improvement of LECO distribution network
- (c) The lease must, within one year of commencement of the lease, develop the said land, in such a manner as to captivate the mind of the Provincial Land Commissioner/Divisional Secretary.
- (d) The buildings constructed must be maintained in a proper state of repair.
- (e) This lease must also be subject to other special conditions stipulated and imposed by the Divisional Secretary and by other institution.
- (f) Once the land is given on lease and in the event of failure on the part of the lessees to substantiate within the specified time frame the purpose for which the land was obtained, action will be taken to terminate the lease.
- (g) No sub-leasing or transferring can be done until the expiry of a minimum period of 05 years from 27.08.2018.

(h) Payment of the lease must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse.

If acceptable reasons are not submitted to me in writing within six weeks of the date of publishing this Notification in the *Gazette* to effect that this land must not be given on leasing, the land will be leased out as requested.
