ATTENTION to Regulations relating to pilgrimages published in *Gazette* No. 9859 dated 30.04.1948, No. 10000 dated 22.07.1949, No. 11255 dated 07.02.1958, No. 12508 dated 07.07.1961, No. 12947 dated 02.03.1962. I hereby notify the following particulars relating to those regulations.

01. Camp Area :

“Camp area” means (a) the area within a radius of a 1.6 km from the ford of the Manik Ganga at Kataragama and (b) the area within a radius of 0.4 km from the Pulleyar Kovil at Sella Katharagama.

02. Construction of Buildings :

No Person Shall construct any building or boutique whether permanent or temporary within the camp area during the period of 13th July, 2018 to 28th July, 2018 without a written permission obtained from any other authorized officer.

03. Beggars :

No Person shall solicit alms within the camp area except in the beggar hut constructed near the second bridge over the Menik Ganga or within a distance of four meters from there and no person shall distribute any alms to beggars within the camp area except at the aforesaid places.

04. Bathing and washing :

No person shall bath or wash cloths or animals within the area of 4.8 km upward the Manik Ganga extending from the place of pumping water through the Katharagama Water Supply Scheme.

05. Vehicles :

5.1 No person shall enter any motor vehicle, bicycle bullock cart or any other vehicle to the sacred area (Eastern part of Menik Ganga) without a permit issued by me or any other authorized officer.

5.2 No Person shall park any vehicle within the camp area except within the areas reserve for parking vehicles in the new town.

06. Barber Saloons :

No Person shall establish any barber saloon within the camp area except the places reserved for the purpose.

07. Kavadi Kada :

No person shall establish any Kavadi Kada without a permit issued by me or any other authorized officer.

08. Marketing :

8.1 Hawkers are not allowed to sell anything within the sacred area pilgrims rest area bus stand and on or near foot bridges No. 01 and No. 02.

8.2 No person shall sell “ Thinnoru, Ice – Cream, Pooja Bhanda Pooja trays, Food items or any other commodities outside the areas reserved for that purpose.

8.3 No person shall establish or maintain any sale outlet within the sacred area except selling of flowers within the sheds already constructed on either sides of the road leading to Kirivehera.

8.4 Every building and every boutique shall have a dustbin and all refuse should be deposited therein.

8.5 All processed foods exposed for sale should be kept in boxes with covers so as to protect them from flies.

Notes to the Financial Statements

1. Significant Accounting Policies

1.1 General Policies

1.1.1 Reporting Entity

Sabaragamuwa University of Sri Lanka has been incorporated under the Universities Act, No. 16 of 1978 and located at P.O. Box 02, Belihuloya. This is a National university mainly operates on government funds.

1.1.2 Principal activities and nature of operations

The university primarily caters to local students in the fields of Agricultural Sciences, Social Sciences, Applied Sciences and Management Studies. The university is promoting higher studies and researches. Faculty of Graduate Studies initiated its operations during the year 2016.

1.1.3 Basis of preparation

(a) Statement of Compliance

The Financial Statements comprise the statements of financial position, statement of financial performance, statement of changes in equity, cash flow statements and notes to the financial statements.

The Financial Statements of the Sabaragamuwa University of Sri Lanka are prepared in conformity with Sri Lanka Public Sector Accounting Standards for the accrual basis of accounts. All accounting policies adopted by the University are applied consistently with those of the previous year, where necessary comparative figures have been adjusted to conform to the changes, in presentation of current year figures.

(b) Basis of measurement

The Financial Statements of the Sabaragamuwa University of Sri Lanka are prepared under the Historical Cost convention and do not take into account of changes in money values, except where it is stated.

(c) Functional and presentation currency

The Financial Statements are presented in Sri Lankan Rupees, which is the University's functional and presentation currency.

(d) Going concern

The Financial Statements have been prepared on a going concern basis.

1.2 Assets and the basis of their valuation

1.2.1 Property, Plant & Equipment

Lands, Buildings, Laboratory and Teaching Equipment, Fixtures & Fittings, Library Books and Periodicals, Motor Vehicles, Cloaks and Other Assets include the items acquired out of government grant, research grants, internally generated funds, and donations.

(a) Basis of Recognition and Measurement

Property, Plant and Equipment are recognized if it is probable that future economic benefits associated with the item will flow to the entity and the cost of the item can be reliably measured. Properties, plant and equipments are recorded at cost less accumulated depreciation. The cost of property, plant and equipment is the cost of purchase or construction together with any incidental expenses thereon.

(b) Cost

The cost of property, plant and equipment comprises its purchase or construction cost and any directly attributable cost of bringing the assets working condition for its intended use.

(c) Subsequent expenditure on existing Fixed Assets

Expenditure incurred on tangible fixed assets is charged to the Statement of Financial Performance in the period it is incurred, unless it meets one of the following criteria, in which case it is capitalized and depreciates on the relevant basis.

- Market value of fixed assets has subsequently increased.
- Asset capacity increase.
- Sustainable improvement in the quality of output or reduction in operating cost.
- Significant extension of the asset life beyond that confirmed by repair and maintenance.

(d) Depreciation

Depreciation is recognized in the Statement of Financial Performance on a Straight –Line Method over the estimated useful life of Property, Plant and Equipment items from the date that they were made available for use. Lands are not depreciated. The estimated useful life periods are as follows.

Depreciation is provided in full in the year of purchase and no depreciation is charged in the year of disposal. This method of depreciation is adopted in using the rates in the UGC circular 649 from the financial year 2006 and hope to continue in future. Also this method of calculation of depreciation was approved by our Council at its 117th meeting held on 20.01.2007.

The vehicle No. SG KE 9206, Motor car purchased in 2007 was fully damaged and condemned in 2016. The National Insurance Trust Fund agreed to provide maximum value of Rs. 2,650,000.00 as insurance recovery in the near future. Hence, the amounting to Rs. 2,650,000.00 has been accounted as insurance receivable in the statement of financial position and net value of the cost & insurance receivable has been charged to the statement of financial performance in 2016.

(e) Capital Works in Progress

Capital work-in-progress is stated at cost. These are expenses of a capital nature directly incurred in the construction of property, plant and equipment awaiting capitalisation. Capital work-in-progress would be transferred to the relevant asset category in property, plant and equipment, when it is available for use i.e., when it is in the location and condition necessary for it to be capable of operating in the manner intended by the university.

1.2.2 Intangible Assets

An Intangible asset is recognized only when its cost can be measured reliably and it is probable that the expected future economic benefits that are attributable to it will flow to the company.

Intangible assets acquired separately are measured on initial recognition at cost. Following initial recognition, intangible assets are carried at cost less any accumulated amortization and any accumulated impairment losses. Subsequent expenditure is capitalized only when it increase the future economic benefits embodied in the assets. All other expenditure is expensed as incurred.

All intangible assets are considered to have a finite useful life and amortized using straight line method to write down the cost of intangible asset to their residual values over their estimated useful lives as follows.

- a. Computer software is amortised over a period of 5 years on straight-line basis.
- b. Cost of development of new curriculum is amortised over a period of 5 years on Straight-line basis from the effective date of the new curriculum.

Intangible assets represent the software purchased under the HETC grant on their written down value and software purchased by the entity during the current financial year.

1.2.3 Curriculum Revision

The university revises the curriculum for all degree programs in every five years and amendments are not making within that period. Hence, the expenditure incurred on capital funds are amortize over the five years period on the basis that the economic benefits would flow to the university during the effective period of the new syllabus. Since the faculty of Management Studies and Faculty of Geomatics have implemented the revised curriculum w.e.f. 2015, the expenditure incurred on that are amortizes w.e.f. 2015. Also since the Faculty of Agricultural Sciences and the Faculty of Applied Sciences have implemented the revised curriculum w.e.f. 2016, the expenditure incurred on that are amortizes w.e.f. 2016.

1.2.4 Knowledge Enhancement

The expenditure incurred to enhance the knowledge of the employees is treated as capital expenditure and amortize over 5 year period.

1.2.5 Livestock

Livestock are revalued and revaluation surplus / deficit charged to the statement of financial performance.

1.2.6 Inventories

Inventories are stated at the lower of cost and net realizable value. In general, cost is determined on a first in first out basis and includes expenditure incurred in acquiring the inventories and bringing them to their existing condition and location.

1.2.7 Receivables

Receivables are stated at the amounts they are estimated to realize.

1.2.8 University Research Grant

As per the SLPSAS 20, no intangible asset arising from research phase of an internal project shall be recognized. Expenditure on research phase activities shall be recognized as an expense when it is incurred. An intangible assets arising from development phase of an internal project shall be recognized if an only if the entity can demonstrate the recognition criteria. This Standered is adopted from the current financial year with retrospectively and hope to continue in future.

The university has allocated funds to enhance research and development activities under the annual capital budget. The total amount spent for the research phase activities are shown as an expense in statement of financial performance. The aggregate amount of research expenditure recognized as expenditure during the year of 2016 is Rs.5, 611,980.

Also the amount spent for research phase activities and recognized as an asset for the year 2015 was Rs. 555,745.00 which is recognized as an expense and adjusted surplus and deficit of 2015 during the current financial year due to the adoption of SLPSAS 20 retrospectively.

1.2.9 Cash & cash equivalents

Cash & cash equivalents comprise cash deposits at banks.

1.3 Liabilities & Provisions

All known liabilities as at the balance sheet date are included in the financial statements and adequate provisions are made for liabilities which are known to exist but the amount of which cannot be determined accurately.

Obligations payable on demand or within one year of the balance sheet date are treated as current liabilities in the balance sheet. Liabilities payable after one year from the balance sheet date are treated as noncurrent liabilities in the balance sheet.

1.3.1 Employee Benefits

(a) Defined Benefit Plans

Defined benefit plans estimate the amount of benefit that an employee will receive on retirement

Provision for retiring Gratuity

The university has adopted the benefit plan as required under the payment of Gratuity Act No. 12 of 1983 for all eligible employees.

Defined benefit plans define an amount of benefit that an employee will receive on retirement usually dependent on one or more factors such as age, years of service and compensation. In order to meet this liability, a provision carried forward as at the reporting date, amount calculated based on an internal management assessment. Accordingly liability recognizes for the employees who have completed 5 years of service in the university system as at the reporting date. The resulting difference between brought forward provision as at the beginning of the period net of any payments made, and the carried forward provision at the end of the period is dealt with in the statement of profit and loss.

The gratuity liability are not externally funded nor actuarially valued.

(b) Defined Contribution Plans

A defined contribution plan is a post-employment plan under which an entity pays fixed contribution into a separate entity and will have no legal or constructive obligation to pay a further amount. Obligations for contributions to defined contribution plans are recognized as an expense in the statement of comprehensive income as and when they are due.

University Provident Fund (UPF) & University Pension Fund

The university and employees, contribute 15% or 7% and 10% respectively, on the salary of each employee to the University provident fund in line with the respective statutes and legislation in Sri Lanka and University Act. Also the university contributes 8% to the University Pension Fund in respect of pensionable employees.

Employees' Trust Fund (ETF)

The university contributes 3% on the salary of each employee to the Employees' Trust Fund.

1.3.2 Leases

Finance Lease

A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to ownership.

Initial Recognition and Subsequent Measurement

Initially, assets held under financial lease and financial lease liabilities are recognized as assets and liabilities in the statement of financial position at their minimum lease payments.

Subsequent lease payments are apportioned between the finance charge and the reduction of the outstanding liability using the effective interest method.

1.3.3 Accounting for Grants

Grants that compensate the University for Expenses incurred are recognized as revenue in the income statement in the same period in which the expenses are recognized. Grants that compensate the University for the Cost of an asset are recognized in the income statement on a systematic basis over the useful life of the related asset.

As per Sri Lanka Public Sector Accounting Standard 20 the university adopted income approach accounting principal when identifying capital grants and donations w.e.f. 2014.01.01 and hope to continue in future.

1.3.4 Contingent Liabilities

Below mentioned all court cases are ongoing and we have to incur legal fees. Some compensation cannot be estimated at the moment. Therefore, no provision has been made in the accounts with regard to liabilities arising out of litigation. Ongoing court cases as at the balance sheet date are stated below.
