- 2. Applicants should permanent residents of the authority areas of Ganga Ihala Korale Pradeshiya Sabha and should establish a period of minimum 03 years permanent residency immediate preceding to the closing date of application. (should forward the residency certificate)
- 3. Age limits is not less than 18 years and not more than 45 years at the closing date of applications.
- 4. Should possess the minimum qualifications prescribed for every post herein.
- 5. Suitable applicants who score highest marks will be selected according to the results, by checking qualifications through a formal interview.
