Purpose of the Bill is to incorporate the said "Indira Cancer Care Trust" which has the following General Objects:-

- (a) To support the national cancer control programme to reduce the number of cancer cases and deaths and improve the quality of the cancer patients through implementing systematic, equitable and evidence-based strategies for prevention, early detection diagnosis, treatment and palliation;
- (b) Prevention of Cancer- As 30-50% of all cancer cases are preventable to support the most cost- effective long-term strategy for the control of cancer to raise awareness to reduce exposure to cancer risk factors and to ensure that people are

provided with the information and support they need to adopt healthy lifestyles;

on detecting symptomatic patients as early as possible by providing care at the earliest possible stage; etc.

(c) Early diagnosis of Cancer- Early diagnosis generally increases the chances for successful treatment by focusing
