BY virtue of powers vested in the Pradeshiya Sabha Bingiriya under 122 of Pradeshiya Sabha Act, No. 15 of 1987 to be read with Sub Section 126(IX) and Section 126 (XI) of the said Act, the following by law on Elimination of annoyance caused towards public by pig farming and ensuring public health within the area of authority of Pradeshiya Sabha Bingiriya made by the said Pradeshiya Sabha has been adopted in terms of the adoption of resolution No. 05-11 (6) at the special General Council held on 12.03.2019. By virtue of powers vested in me under Section 123 of Pradeshiya Sabha Act, No. 15 of 1987 to be read with the aforesaid Section 2 of Provincial Council (Incidental Provisions) Act, No. 15 of 1987, I, Peshala Jayarathne Bandara the Hon. Governor in the North Western Province hereby notify that the said by law has been approved by me.

BY LAW ON ELIMINATION OF ANNOYANCE CAUSED TOWARDS PUBLIC BY PIG FARMING AND ENSURE PUBLIC HEALTH

- 1. This by law is enacted for making provisions for the elimination of annoyance caused towards public by maintenance of pig farming for obtaining pork, for breeding of pigs, and for the preparation of food for pigs, maintaining places for processing pork, for disposal of waste and transporting pigs along public roads within the area of authority of Pradeshiya Sabha Bingiriya and to ensure public health.
- 2. This by law is enacted under Sections 126 (iX) and 126 (Xi)) to be read with Section 122 (1) of Pradeshiya Sabha Act, No. 15 of 1987.
- 3. This by law is cited as the by law on elimination of annoyance caused towards public by pig farming and ensuring public health within the area of authority of Pradeshiya Sabha Bingiriya.
- 4. Every person who maintains a place within the area of authority of Pradeshiya Sabha Bingiriya for rearing pigs for obtaining pork, breeding of pigs, preparation of food for pigs and processing pork shall obtain a license specified in schedule No. I of this by law from the Chairman of the Pradeshiya Sabha.
- 5. Every person who applies for a license under the above Section 4 shall apply through an application substantially prepared in accordance with the Schedule II of this by law.
- 6. Fees levied for a license and an application for obtaining a license under this by law shall be decided upon an adoption of resolution published by a *gazette* notification by the Pradeshiya Sabha from time to time.
- 7. There shall be a committee consisting the following officers to provide instructions and recommendations with regard to the implementation of the provisions under this by law.
 - (a) Secretary Chairman to the Sabha
 - (b) Medical Officer of Health or his agent Committee Member
 - (c) Veterinary or his agent or his agents Committee Member

- (d) Technical officer of the Sabha Committee Member
- (e) Environment Officer of the Sabha Committee Member
- (f) An Agent of Divisional Secretary of the relevant Divisional Secretariat Division Committee Member
- 8. Every person who applies for a license under the above Section 4 shall fulfill the following conditions.
 - (*a*) Every construction made at the relevant premises for which the license is applied shall be constructed in conformity with a prescribed plan approved by the Chairman.
 - (b) The maximum number of pigs to be reared in any building shall be decided by the Chairman, considering the age limits of the animals and the minimum area to be allotted for each grown animal shall be considered as 10 sq.ft.
 - (c) Every premise shall be covered with an adequate height and the height to be covered shall be decided by the Chairman considering the recommendation of the committed set out under Section 7.
 - (*d*) Every construction relevant to the business of the premises under the license shall beconstructed at the minimum distance of 15 meters from the poultry houses and if a public premises or a neighbouring land adjacent to the said premises is located it shall be covered with a parapet wall.
 - (e) The minimum distance from a pig farm to the boundary of a land in which the farm is located relevant to the license shall be as follows.
 - I. In case the domestic level pig farms the minimum distance from the pig farm to the boundary of the land shall be 10 meters.
 - II. In the case of minor scale pig farms the minimum distance from the pig farm to the boundary of the land shall be 15 meters.
 - III. In the case of medium scale pig farms the minimum distance from the pig farm to the boundary of the land shall be 20 meters.
 - IV. In the case of major scale pig farms the minimum distance from the pig farm to the boundary of the land shall be 50 meters.
 - V. The minimum distance between two pig farms within a premise shall be 2 meters.
 - (*f*) It shall be lawful for the Chairman to take necessary action considering the recommendations of the committee in respect of business places which are not complied with the distances specified under Section I, II, III, IV, V of this by law, from the effective date of this by law. In case dissatisfied about the said decision an appeal could be submitted the Provincial Commissioner and his decisions shall be final and conclusive.
 - (g) Every construction relevant to the license applied shall be located at the minimum distance of 15 meters from a water source, well or a water course.
 - (*h*) In case the premises for which the license is applied is a food and meat processing center, appropriate measures shall be taken to control the sound generated by the machinery without causing annoyance towards the public.
 - (*i*) The waste generated at the premises shall be disposed to a septic pit and provided that, in case a medium scale pig farm waste shall be directed to a bio gas unit and shall be refined and in case of a major scale pig farm waste shall be directed to a bio gas unit or a waste treatment system and shall be refined.
 - (*j*) The constructions made at the premises under the license applied shall be made to prevent from leaking or mixing water from the rain or any other way and a covered drainage system shall be constructed for drainage of wasted water within the premises.

- (*k*) Every premises where a major scale pig farm is maintained under a license, the minimum distance of the premises from a temple, another a religious place, a school, a hospital or a public place decided by the Committee set out under Section 7 in this By laws, shall be 300 meters and in case a medium scale or minor scale pig farm the minimum distance from the above place shall be 200 meters.
- (*l*) The drainage system of the premises relevant to the license applied shall be directed to a septic tanks within the premises so as to prevent from joining another premises or a public drain or a natural water way and the tank where pigs are reared shall be concreted and tiled.
- (*m*) Every licensed premise shall have the capacity of storing water from an adequate water source, and in case supplying water from the outside water resources a certificate issued by the National Board of Water Supply and Drainage shall be obtained to the effect that adequate water storing facilities are available and shall be submitted whenever required.
- 9. Unless every permit issued under Section 4 of this by law is cancelled upon the violation of the Sections in this by law, the validity of the said license shall be ended on 31st of December of the year in which the license is issued.
- 10. Every licensed premises shall,
 - (a) have adequate facilities for rearing animals,
 - (b) methodically dispose the waste generated at the premise and take appropriate measures to control the bad odor generated at the premise.
 - (c) maintain the drains daily and cause to construct drains so as to flow water easily.
 - (*d*) Any waste material removed from the premise shall be used for manure and it should be buried in a pit specifically prepared for the said purpose and in any case shall not be heaped at the open space of the premises. Waste disposed under this Sub Section shall not be whatever manner buried unless the minimum distance from a water source is 30 meters.
 - (e) It shall be lawful to take action to dispose the waste generated at the pig farm premises as per the supervision of the committee. Further, if the waste generated at the pig farm premises is dumped to another land the procedure to be followed by the licensee may be ordered by the Chairman under the recommendations of the committee set out under Section 7.
 - (f) Every employee shall wear sanitary tools and the licensee shall responsible for ensuring to that effect.
 - (g) Toilet facilities and lavatory facilities shall be adequately provided for the workers employed at the premises and those toilets and lavatories shall be maintained in proper sanitation.
 - (*h*) In case of gas emission is taken place on account of a bio gas, such emission of gas should be released incompliance with the detoxification standards.
 - (*i*) A person who is suffering from a communicable or infectious disease or has been attending to any person suffering from a communicable or infectious disease during the incubation period shall not be employed.
 - (*j*) If adequate facilities are not provided for storing left-over or parts of animals which are brought for the purpose feed the pigs such left-over or parts of animals shall not be kept more than one day and when such left-over and parts of animals are transported they shall be transported in covered receptacles.
 - (k) A suitable place shall be properly maintained for cooking food and for consuming food for the employees.
 - (*l*) In case the premises is a place where meat is processed the equipment and tools used for processing meat shall be maintained with proper hygiene and standard facilities shall be provided for storing and packing meat.

- (m) Animals died from diseases shall be destroyed and a special place shall be maintained for that purpose. A vacummed disposal pit shall be maintained for that purpose and it shall be constructed 100 meters away from the pig farms in conformity with the standards.
- (n) Proper measures shall be taken to prevent breeding of vectors and to control stray predators and to control bad smell in the premises.
- (o) In case epidemic diseases are spread, recommendations prescribed by the Veterinary Specialist, or Veterinary Surgeon and the Chairman shall be implemented and in case the parts of animals of dead animal are disposed upon the recommendation of the above three persons the said waste shall not be disposed to a road, canal, stream or public place or a private place decided by the committee set out in the Section 7 hereto.
- (p) Animal waste or parts of the animals shall not be burnt in the open air for the purpose of destroying them.
- (q) Pigs in the farms shall be properly vaccinated as prescribed and a certificate shall be obtained to the effect that such vaccines have been given to the animals and shall submit whenever required.
- (r) Meat of naturally died animals any how shall not be sold in any way for human consumption.
- (s) Slaughtering of animals shall not be made in any licensed premises without having a license issued under Butchers' Ordinance.
- 11. It shall be lawful for the Chairman or any officer authorized in that behalf by the Chairman to enter into a premises of the area of authority of Pradeshiya Sabha relevant to the license issued under this bylaw, request information, and inspect documents during the usual hours between 6.00 a.m. to 6.00 p.m. or upon the exigency of inspection in order to ensure whether the premises is maintained inconformity with the conditions set out in this by law.
- 12. In case the Chairman is satisfied to the effect that a licensee violates the provisions set out in this by law a specific period shall be given to the licensee by means of issuing a written notification advising him to comply with the by law.
- 13. In case the licensee requests the Chairman to grant an additional period to comply with the notification made under section 12 of this by law, such an additional period could be granted by the Chairman and the aforesaid period shall not exceed a period of 180 days from the effective date of this by law.
- 14 It shall be lawful for the Chairman to cancel the relevant license in case the licensee fails to comply with the notification made under this by law and due to further violation of any Section of this by law.
- 15. Violation of any Section of this by law shall be an offense and in case the person who violates the by law is found guilty by a competent court of law shall be liable for punishment under Section 122 (2) of Pradeshiya Sabha Act, No. 15 of 1987
- 16. In case pigs are transported from one premises to another premises within or outside this area of authority as per a license under this by law the transportation should be taken place only between 6.00 a.m to 6.00 p.m.
- 17. In this context of the by laws unless otherwise requires:

Chairman means the Chairman of the Pradeshiya Sabha Bingiriya,

Sabha means Pradeshiya Sabha Bingiriya,

Authorized Officer means an officer specifically authorized by the Chairman for a particular purpose,

Domestic Farm means a farm consisting 1-4 pigs at the time of applying for a license,

Minor Scale Farm means a farm consisting pigs between 5-24 at the time of applying for the license,

Medium Scale Farm means a farm consisting pigs between 25-49 at the time of applying for the license,

Major Scale Farm means a farm consisting more than 50 pigs at the time of applying for the license.

A representative of the Divisional Secretary of the Relevant Divisional Secretariat Division means an agent authorized by the Divisional Secretary of the relevant Divisional Secretariat division where the industry is maintained.

A Public place means any road, thoroughfare, street, lane, Deweta, Pavement, a public land, any reservation, a sports ground, a public building, a public cemetery, a bus stand, a railway station, a river, a canal, brook, tank, pond, lagoon, water source, rain water drain, beach, any land owned by the Sabha, a government land reserved for public utilization or any other place.

18. In the event of any inconsistency between the Sinhala and Tamil and English text in this by law the Sinhala text shall prevail.

- 2. This by law is enacted under Sections 126 (ix) to be read with Section 122 (1) of Pradeshiya Sabha Act No. 15 of 1987.
- 3. This by law is cited as the by law on elimination of annoyance caused towards public by Poultry farming and ensuring public health within the area of authority of Pradeshiya Sabha Bingiriya.
- 4. Every person who maintains a place within the area of authority of Pradeshiya Sabha Bingiriya for obtaining chicken and eggs, breeding of chicks, preparation of food for poultry and processing chicken shall obtain a license specified in schedule No. I of this by law from the Chairman of the Pradeshiya Sabha.

 - (e) The minimum distance from a poultry house to the boundary of a land in which the farm is located relevant to the license shall be as follows.
 - I. In the case of minor scale poultry farms the minimum distance from the poultry farm to the boundary of the land shall be 15 meters.
 - II. In the case of medium scale poultry farms the minimum distance from the poultry farm to the boundary of the land shall be 20 meters.
 - III. In the case of major scale poultry farms the minimum distance from the poultry farm to the boundary of the land shall be 50 meters.

- IV. The minimum distance between two poultry houses within a premise shall be 6 meters. Provided that, in case the poultry houses where fowls are reared for meat the minimum distance shall be 9 meters.
- V. Every premises where a major scale poultry farm is maintained under a license, the minimum distance of the premises from a temple, another a religious place, a school, a hospital or a public place decided by the committee set out in Section 7 shall be 300 meters and in case a medium scale or minor scale poultry farm the minimum distance from the above place shall be 200 meters.
- (*f*) It shall be lawful for the Chairman to take necessary action considering the recommendations of the committee in respect of business places which are not complied with the distances specified under Section I, II, III, IV, V of this by law, from the effective date of this by law. In case dissatisfied about the said decision an appeal could be submitted the Provincial Commissioner and his decisions shall be final and conclusive.
- (g) Every construction relevant to the license applied shall be located at the minimum distance of 15 meters from a water source, well or a water course.
- (*h*) In case the premises for which the license is applied is a food and meat processing center, appropriate measures shall be taken to control the sound generated by the machinery without causing annoyance towards the public.
- (*i*) The waste generated at the premises shall be disposed to a septic pit and it shall be water sealed.
- (*j*) The constructions made at the premises under the license applied shall be made to prevent from leaking or mixing water from the rain or any other way and a covered drainage system shall be constructed for drainage of wasted water within the premises.
- (*k*) The drainage system of the premises relevant to the license applied shall be directed to a septic tanks or a absorbing pit within the premises so as to prevent from joining another premises or a public drain or a natural water way.
- 9. Unless every permit issued under Section 4 of this by law is cancelled upon the violation of the Sections in this by law, the validity of the said license shall be ended on 31st of December of the year in which the license is issued.
- 10. Every licensed premises shall,
 - (*a*) methodically dispose the waste generated at the premise and take appropriate measures to control the bad odor generated at the premise.
 - (b) maintain the drains daily and cause to construct drains so as to flow water easily.
 - (c) When the rice husk lining laid inside the poultry houses is removed, it could be removed for manure and it shall not be ever heaped at the open space of the premises so as to wet with water. It shall be kept and stored in covered bags until transported them outside the farm.
 - (*d*) If the lining of rice husk laid at the poultry premises is continuously used without disposal, it shall be utilized as per the manner ordered by the Chairman under the recommendations of the committee specified in this by law.
 - (e) Every employee shall wear sanitary tools and the licensee shall responsible for ensuring to that effect.
 - (*f*) Toilet facilities and lavatory facilities shall be adequately provided for the workers employed at the premises and those toilets and lavatories shall be maintained in proper sanitation.
 - (g) In case of gas emission is taken place on account of a certain production procedure such emission of gas should be released incompliance with the detoxification standards.

- (*h*) No person who is suffering from a communicable or infectious disease or has been attending to any person suffering from a communicable or infectious disease during the incubation period shall not be employed.
- (*i*) If the place is a farm rearing fowls for eggs, broken eggs produced shall be disposed and eggs shall not be kept or stored in a manner so as to contact faeces or any other waste and those eggs shall be cleaned well and properly placed.
- (*j*) A suitable place shall be properly maintained for cooking food as well as for consuming food for the employees.
- (*k*) In case the premises is a place where meat is processed the equipment and tools used for processing meat shall be maintained with proper hygiene and standard facilities shall be provided for storing and packing meat.
- (*l*) All the damaged eggs and died fowls shall be destroyed and a special place shall be maintained for that purpose. A vacuumed disposal pit shall be maintained for that purpose and it shall be located 15 meters away from the residence. The disposal pit shall be constructed 15 meters away from a water resource.
- (*m*) Proper measures shall be taken to prevent breeding of vectors and to control stray predators in the premises.
- (n) Bird waste or parts of the birds shall not be burnt in the open air for the purpose destroying them.
- (*o*) In case epidemic diseases are spread, recommendations prescribed by the Veterinary Specialist, or Veterinary Surgeon and the Chairman shall be implemented and the parts of fowls or any other waste materials shall not be disposed in any case to a road, canal stream, public place or a private place.
- (*p*) Waste and parts of fowls generated at the premises shall not be disposed to an open space or collected other than disposing to a coverable vessels or receptacles with lids prepared for the said purpose
- 11. It shall be lawful for the Chairman or any officer authorized in that behalf by the Chairman to enter into a premises of the area of authority of Pradeshiya Sabha relevant to the license issued under this bylaw, request information, and inspect documents during the usual hours between 6.00 a.m. to 6.00 p.m. or upon the exigency of inspection in order to ensure whether the premises is maintained inconformity with the conditions set out in this by law.
- 12. In case the Chairman is satisfied to the effect that a licensee violates the provisions set out in this by law a specific period shall be given to the licensee by means of granting a written notification advising him to comply with the by law.
- 13. In case the licensee requests the Chairman to grant an additional period to comply with the notification made under section 12 of this by law, such an additional period could be granted and the aforesaid period shall not exceed a period of 180 days from the effective date of this by law.
- 14. It shall be lawful for the Chairman to cancel the relevant license in case the licensee fails to comply with the notification made under this by law and due to further violation of any Section of this by law.
- 15. Violation of any Section of this by law shall be an offense and in case the person who violates the by law is found guilty by a competent court of law shall be liable for punishment under Section 122 (2) of Pradeshiya Sabha Act, No. 15 of 1987
- 16. In case pigs are transported from one premises to another premises within or outside this area of authority as per a license under this by law the transportation should be taken place only between 6.00 a.m to 6.00 p.m.
- 17. In the event of any inconsistency between the Sinhala and Tamil and English text in this by law the Sinhala text shall prevail.

18. In this context of the by laws unless otherwise requires:

Chairman means the Chairman of the Pradeshiya Sabha Bingiriya,

Sabha means Pradeshiya Sabha Bingiriya,

Suitable material means bricks or other mortar, or asbestoses, sheet or other substance specilly made of,

Poultry means fowls, turkey reared for eggs of meat.

Authorized Officer means an officer specifically authorized by the Chairman for a particular purpose,

person means a person or a board of persons incorporated or not incorporated

Minor Scale Farm means a farm consisting fowls between 50-1,000 at the time of applying for the license,

Medium Scale Farm means a farm consisting fowls between 1,001 - 2,499 at the time of applying for the license,

Major Scale Farm means a farm consisting 2500 or more than 2,500 fowls at the time of applying for the license.

A representative of the Divisional Secretary of the Relevant Divisional Secretariat Division means an agent authorized by the Divisional Secretary of the relevant Divisional Secretariat division where the industry is maintained.

A Public place means any road, thoroughfare, street, lane, Deweta, Pavement, a public land, any reservation, a sports ground, a public building, a public cemetery, a bus stand, a railway station, a river, a canal, brook, tank, pond, lagoon, water source, rain water drain, beach, any land owned by the Sabha, a government land reserved for public utilization or any other place.
