Press and from the date of publication, thereby enabling those interested in the contents of such notices to actively and positively participate please note that inquiries and complaints made in respect of corrections pertaining to notification will not be entertained after three months from the date of publication.

All notices to be published in the weekly *Gazettes* should reach Government Press two weeks before the date of publication *i.e.* notices for publication in the weekly *Gazette* of 19th July, 2019 should reach Government Press on or before 12.00 noon on 05th July, 2019.

# BY LAW ON MANAGEMENT OF AREAS WITHIN THE AREA OF AUTHORITY OF PRADESHIYA SABHA KALPITIYA FOR THE PURPOSE OF CONDUCTING KITE SURFING TRAINING

THE by law on management of areas within the area of authority of Pradeshiya Sabha Kalpitiya for the purpose of training on kite surfing set out in the following Schedule which has been compiled by the Pradeshiya Sabha Kalpitiya by virtue of powers vested in the Pradeshiya Sabha under Sub Section (1) of Section 122 of Pradeshiya Sabha Act, No. 15 of 1987 to be read with Section 126 of the said Act has been passed under the motion No. 11(8) at the General Meeting held at the Pradeshiya Sabha Kalpitiya on 09 April 2019.

Accordingly, I, Peshala Jayarathne Bandara the Hon Governor in the North Western Province hereby notify that the said by law has been approved by me by virtue of powers vested in me under Sub Section (1) of Section 123 of aforesaid Pradeshiya Sabha Act to be read with Section 2 of Provincial Council (Incidental Provisions) Act, No. 12 of 1989 and it is further notified that the said by law shall be effective within the said area of authority from the date of publication of this notification in the *Gazette* Paper.

### By Law on Management of Areas for the training purpose of windsurfing and Kite surfing

- 1. This by law is imposed for making provisos in respect of the control and management of lagoon and coastal areas (hereinafter known as areas) around that lagoon which have been named as suitable areas for conducting training services of windsurfing and kite surfing by the Divisional Secretary within the area of authority of Kalpitiya under the control and management of Pradeshiya Sabha Kalpitiya.
- 2. This By law is enacted under Section 122(1) to be read with Section 126 (vi) of Pradeshiya Sabha Act, No. 15 of 1987.
- 3. This By law is cited as the By law on management of areas for the purpose of training of windsurfing and kite surfing of the Pradeshiya Sabha Kalpitiya.
- 4. (i) No person or an institute shall engage in windsurfing and kite surfing training at the areas relevant to this By law unless possessing a permit substantially issued by the Chairman under Schedule I of this By Law.
  - (ii) The maximum number of permits that could be issued for a person in respect of a certain place maintained for the purpose of training shall be decided upon the extent of length meters of the place of relevant coastal belt.
  - (iii) No person shall engage in training of trainees exceeding the permitted number of trainees for himself.
  - (iv) In case trainers are engaged in the training activities every trainee in each institute shall wear different colored coats as advised by the Pradeshiya Sabha so as to recognize each training institute.
- 5. (i) Every person who applies for a permit under the aforesaid Section 4 shall apply for such permit by obtaining an application substantially prepared under Schedule II of this by law on payment of a fee to the Pradeshiya Sabha Kalpitiya.
  - (ii) Prescribed fees to be paid for an application under this Section shall be decided and declared upon an adoption of resolution moved from time to time by the Pradeshiya Sabha.
  - (iii) Prescribed fees under this Section shall be decided by the Sabha on the basis of an annual permit and considering the number of trainees for each permit.

- 6. Every permit issued under Section 4 of this By law, shall be ended on 31st December of the particular year in which the permit is issued unless it is cancelled earlier on account of violation of conditions of this By law.
- 7. Every person who applies for a permit under this By Law shall have completed the following conditions.
  - (i) Should have been registered for the said purpose at the Sri Lanka Tourist Board.
  - (ii) The training should be conducted under qualified trainers who have obtained international training licenses for windsurfing and kite surfing and that should be verified by a valid training license.
  - (iii) In case a training center is maintained at the lagoon and coastal area, the relevant constructions shall be constructed in accordance with a plan approved by the Department of Coastal Conservation and a copy of the approved plan should be annexed.
  - (iv) A report recommended by the Medical Officer of Health to the effect that sanitary facilities including First Aid facilities for the trainees have been properly maintained shall be submitted together with the relevant request.
- 8. The maximum number of permit to be issued in respect of identifying a coastal and a lagoon belt or for an identified coastal and lagoon belt within this area of authority for training purposes shall be decided by a committee consisting Divisional Secretary, Secretary to the Pradeshiya Sabha, Manager in charge of the Division of Kalpitiya of the Department of Coastal Conservation, Assistant Director Fisheries, Regional Officer of the Tourism Development Authority and Deputy Director of Urban Development Authority upon the consent of District Lagoon Management Committee.
- 9. The duration of training under a permit shall be conducted from 9.00 to 06.00 hours and no person shall engage in training activities excluding such hours.
- In case coastal line and lagoon line are utilized for the training purpose the coastal area specifically allocated for fisheries activities shall not be used.
- 11. Pradeshiya Sabha shall provide facilities for training activities conducted under this bylaw.
- 12. Issue of a temporary permit substantially with the Schedule III of this by law by the Chairman for a time period decided by the Pradeshiya Sabha Kalpitiya in respect of engaging in windsurfing and kite surfing at a certain part of Lagoon belt maintained by the Pradeshiya Sabha Kalpitiya, under the agreement entered into between the Divisional Secretary Kalpitiya and the Pradeshiya Sabha Kalpitiya, shall be lawful and in order to obtain such permit an application prepared substantially with the Schedule IV of this By Law obtained by the Pradeshiya Sabha Kalpitiya shall be forwarded.
- 13. Fees to be levied for a permit under Section 12 shall be decided by the Pradeshiya Sabha and subsequently shall be published in the *Gazette* paper.
- 14. Any person who resided within the area of authority of Pradeshiya Sabha Kalpitiya engages in windsurfing and kite surfing at the coastal belt for entertainment shall not be relevant for the purpose under this by law.
- 15. Violation of any provision of this by law shall be an offense and a maximum fine may be imposed in case a person is found guilty of that offense by a proper judicial court and if such offense is further continued by the said person notwithstanding the handing over of a written notification by the Chairman or any authorized officer stating the offense, an additional punishment shall be imposed for each day of violation and the maximum of fine or maximum of additional punishment shall be imposed under Sub Section (2) of Section 122 of Pradeshiya Sabha Act, No, 15 of 1987.
- 16. In the event of any inconsistency between the Sinhala, Tamil and English text in this By law the Sinhala text shall prevail.

- 17. In this context unless otherwise requires,
  - "Chairman" means the Chairman of the Pradeshiya Sabha Kalpitiya,
  - "Sabha" means Pradeshiya Sabha Kalpitiya,
  - "Divisional Secretary" means the Divisional Secretary of the Divisional Secretariat Kalpitiya,
  - "a person" means an institute, person, or a board of persons established under Company Act, No. 07 of 2007 implemented in respect of the maintenance of the training service on kite surfing,
  - "Authorized Officer" means an officer authorized for the said purpose by the Pradeshiya Sabha Kalpitiya.
