NOTIFICATION FOR THE CANCELLATION OF THE GRANT (SECTION 104) ISSUED UNDER THE SUB SECTION (4) OF SECTION 19 OF THE LAND DEVELOPMENT ORDINANCE

I, Buddhika Ruwani Samaratunge Divisional Secretary of the Divisional Secretary's Division - Bandaragama, District Kalutara, Western Province, do hereby inform, that the action is being taken under the Section 104 of the above said ordinance, to cancel the grant No. Kalu/Pra/Ban/446 given to Hatan Arachchige Bandusena of Baddegoda, Bandaragama by His Excellency the President on 17.10.1994, in terms of Section 19(4) of the Land Development Ordinance, as it has been reported that, there is no successor whom legally entitled to possess and or in the case of even there is a successor, he/ she is not willing to be a successor for the above said land which has not been registered in the District Registra's Office and mentioned in the schedule below.
