Press and from the date of publication, thereby enabling those interested in the contents of such notices to actively and positively participate please note that inquiries and complaints made in respect of corrections pertaining to notification will not be entertained after three months from the date of publication.

All notices to be published in the weekly *Gazettes* should reach Government Press two weeks before the date of publication *i.e.* notices for publication in the weekly *Gazette* of 06th March, 2020 should reach Government Press on or before 12.00 noon on 20th February, 2020.

#### NORTH WESTERN PROVINCIAL COUNCIL

#### **Municipal Council Orders**

1. Ahamed Jamaldeen Mohamed Muzammil, who exercises the powers of the Governor of North Western Provincial Council and the minister in charge of the Provincial Council subject to Section 289 of the Municipal Council Ordinance, which is the 252 authority read with Section 2 of the Provincial Councils (Subsidiary Provisions) Act, No. 12 of 1989 of the Municipal Council Ordinance. Amendments relating to the payment of communications and transport allowances to members of Municipal Councils in accordance with the powers vested in them under is imposed.

In Kurunegala, 24th December, 2019.

- 1) The Regulations are referred to as the Communication and Transportation Allowances for Members of Municipal Councils.
- 2) Either maximum amount of communication allowance of Rs. 10,500.00 for mayor of the municipal councils by a formal resolution of the council Rs. 8,500.00 for the Deputy Mayor, Rs. 7,000.00 for other members of the council or maximum amount of the telephone bills can be paid monthly under that limits.
- 3) For members of municipal councils by a formal resolution of the council Transport allowance can be paid subject to a maximum of Rs. 7,000.00.
- 4) These allowances should be paid out of the council fund and if the council is convinced that there is sufficient income for it, the annual budget should have provided for it.
- 5) Municipal Councilors are not entitled to Communication and Transportation allowance in the following cases:
  - I. Attending the General Meeting and Committee Meetings of the month of the payment of allowances without the approval of the General Assembly,
  - II. Detention or imprisonment for any criminal charge,
  - III. The functions and functions of the members of any Municipal Council have been suspended in terms of the Local Authorities (Administration and Supervisory Powers) Statute of the North Western Provincial Council Act, No. 01 of 1991 or Section 277 of the Municipal Council Ordinance.

However, in the event of a period of detention, imprisonment or leave or suspension of service, these allowances may be calculated in proportion to the remainder of the month.

6) Notwithstanding paragraph (a) of paragraph (1) of this Order, Members shall not be deprived of their allowance for non-attendance at a meeting of the Council in the event of a formal approval of a duty.

The Municipal Council Regulations published in the *Gazette* Notification No. 1891 dated 28.11.2014 imposed by the Minister in-charge before the payment of communication allowances to Members of Municipal Councils has been canceled.

In the event of any inconsistency between the Sinhala, Tamil or English texts of this order, the Sinhala text shall prevail.
