NOTIFICATION MADE UNDER STATE LAND REGULATION No. 21(2)

IT is hereby notified that for the Commercial Purpose, Clean Poly Packing Private Limited has requested on lease a state land containing in extent about 0.0049 Hec. in Lot No. 151 and Hectare 0.1569 in Lot No. 152 in zone No. 6 marked in Cadastral Plan No. 610031 prepared by the Surveyor General and kept in charge of superintendent of Surveys Kegalle situated in the Village of Karmanthapura Bumaiya which belongs to the Grama Niladhari Division of

Bisowela coming within the area of authority of Galigamuwa Divisional Secretariat in the District of Kegalle to construct and maintain a Factory on the production and printing of polythen bags.

The land requested can be given on lease for the necessary purpose. Therefore, the government has intended to lease out the land subject to other government approved conditions.

Terms of the lease.- Thirty Years (35) (From 31.07.2012 upto 30.07.2047)

The Annual rent of the lease rent is exempted for the first 5 years from 31.07.2012 upto 30.07.2017.- 4% of the value of the market land, as per valuation of the chief valuer for the year 2012. This amount of the lease must be quinquennially revised in such a manner that the amount as a result of the revision will be not less than 50% of the amount that just preceded.

Premium : Not charged since the land is Karmanthapura lane.

- (a) The lessee must, within one year of the commencement of the lease, develop the said land, in such a manner as to captivate the mind of the Divisional Secretary.
- (b) The lessee must not use this land for any purposes other than for the purpose of Commercial.
- (c) The lease must also be subject to the other special conditions stipulated and imposed by the Divisional Secretary and by other institutions.

(d) Once the land is given on lease and in the event of failure on the part of the lessees to substantiate within the specified time frame the purpose for which the land was obtained, action will be taken to terminate the lease.

(e) No Sub-leasing or transfers can be done until the expiry of a minimum period of 05 years from 31.07.2012 except sub leasing or transfer to fulfil the purpose of this lease ;

(f) Payment of the lease must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse.

(g) The buildings constructed must be maintained in a proper state of repair.

If acceptable reasons are not submitted to me in writing within six weeks of the date which this notice is published in the *Gazette* to the effect that this land must not be given on lease, the land will be leased out as requested.
