### RESALE OF TODDY TAVERN RENT FOR 2021

THE Commissioner General of Excises has been decided to resell the toddy tavern in the reason of not submitting the tender application in the manner of satisfaction of tender board in connection with the selling of above said toddy tavern held at Divisional Secretariat of Udawalpala on 20.08.2020 at 10.30 a.m. in related the year 2021 and the relevant notice and conditions mentioned below.

02. Tenders will be accepted by the Divisional Secretary of Udawalpala up to 10.30 a.m. on 28.09.2020 for the purchase of exclusive privilege of selling fermented liquor by retail at the toddy taverns referred to in the schedule below during the year 2021 subject to the toddy tavern rent sales conditions for 1983 and subsequent periods published in the Government *Gazette* No. 207 of 20th August, 1982 of the Democratic Socialist Republic of Sri Lanka and the general conditions applicable to the excise license of the time being in force.
