APPLICATIONS are called from both male and female candidates who are residing within Central Province and any parts of Sri Lanka; possess required qualifications specified in this notification to fill the vacancies in Technological Service (Civil/Mechanic/Electric/Draughtsman) Grade III and Training Grade of Central Provincial Public Service.

#### 01. General conditions:

- 1.1 Shall be a citizen of Sri Lanka
- 1.2 Shall be of excellent character
- 1.3 Applicants residing any part of the Island shall apply. Applicants who have completed all the qualifications as at the date mentioned in the notification and possess a continues permanent residence for a period of not less than 03 years within Central Province or having married a person holding more than 03 years of permanent residence within Central Province are given priority to fill the vacancies at first and then applicants residing other parts of Island will be considered for the recruitment based on their marks priority on the condition of compulsory service for 05 years.
- 1.4 Applicants applying on open basis shall be not less than 18 years and not more than 35 years of age on the closing date of applications
- 1.5 Should possess the adequate physical and mental fitness required to serve in any area of Central Province and discharge duties of the post
- 1.6 No person who is ordained in any religious order shall become eligible to sit the examination
- 1.7 Shall have completed all the qualifications and conditions prescribed in the notification as at the date mentioned in the recruitment notification

#### 04. Terms of Engagement:

- Terms of Engagement determined by the service minute of the Central Provincial Technical Service
- 70% of the existing vacancies will be recruited under open stream and the remaining 30% will be filled under limited basis
- If the number of vacancies is less than 03, recruitment will be done only under open stream.
- The number of vacancies allocated under the open stream will be recruited at first by the applicants who are eligible under above table 2.1.1 and then applicants will be admitted to the training grades under 2.1.2 and 2.1.3 only if the number is not sufficient to fill the vacancy number.
- If there are not enough internal qualified candidates for the percentage to be recruited from the limited competitive examination, the balance will be filled by the external candidates selected by the open competitive examination itself.

#### 05. Mode of recruitment:

Central Provincial Public Service Commission shall conduct a competitive examination and the candidates obtaining higher marks based on the marks priority will be subjected to an interview for selection of suitable candidates. No marks will be assigned at the interview. Recruitment will be made under the merit of marks obtained in the examination by the candidates. A minimum of 40% marks should be obtained for each question paper. Recruitment for the vacancies will be done based on the merit shown in the examination.

#### 06. Conditions of recruitment:

- 6.1. This post is permanent and pensionable. You shall be subjected to a policy decision taken by the government in future in respect of the pension scheme entitled to you.
- 6.2. Appointment is subject to the provisions in the public P.A. circular 18/2020 issued on Implementation of Official Language Policy
- 6.3. Should serve minimum of 05 years within Central Province once you call upon appointment and any request made for transfer or release to another post outside the Central Province during that period will not be considered.

#### 07. *Method of application*:

- 7.1. Examination fee is Rs. 600/-

The paid examination fee will not be refunded under any circumstances.
- 7.3. Candidates possess permanent residents outside the Central Province should adhere to the following procedure in paying their examination fees:
  - Examination fee should be paid at any People's Bank branch drawn in favour of Secretary of the Central Provincial Public Service Commission, to the Account No. 003-1-001-0-000-6004 maintained by the People's Bank, Kandy and the relevant receipt issued by the Bank should be firmly affixed to the application.

- 10. Syllabus: Open competitive examination consists of two question papers.
  - 01. Intelligence Test (Time 01 hour, Total marks 100)

This paper consists of objective questions to assess the candidate's power of logical reasoning and analysis and ability to draw sound inferences.

02. Technological question paper (Time 03 hours, Total marks - 100)

Consists of multiple Choice Questions and Structural Questions applicable to the post.

a) For the post of Technological Service (Civil) Grade III/ Training Grade to Central Provincial Public Service

This paper is designed for candidates who applied for civil posts consists of questions to test the level of technological knowledge, a civil officer should possess in the field of Building Construction & maintenance, Road construction & Maintenance, and Water Supply & Drainage.

- b) For the post of Technological Service (Mechanical) Grade III to Central Provincial Public Service

  This paper is designed for candidates who applied for Mechanical posts consists of questions to
  test the level of technological knowledge, a Mechanical officer should possess.
