Press and from the date of publication, thereby enabling those interested in the contents of such notices to actively and positively participate please note that inquiries and complaints made in respect of corrections pertaining to notification will not be entertained after **three months** from the date of publication.

All Notices to be published in the weekly *Gazette* should reach Government Press two weeks before the date of publication *i.e.* Notices for publication in the weekly *Gazette* of 04th June, 2021 should reach Government Press on or before 12.00 noon on 21st May, 2021.

KALMUNAI MUNICIPAL COUNCIL

IN terms of the resolution made at the General Committee Meeting of the Kalmunai Municipal Council held on 30.03.2021, it is hereby declared that the border line of the Street Line from the center point of the road within the Kalmunai Municipal Council limit shall be as follows :

1. For the roads which come under the purview of Road Development Authority (Class A) 15 Metes of 50 feet
2. For the roads which come under the purview of Road Development Department
 - i. Class B: 09 Meters or 30 Feet
 - ii. Class C: 7.5 Meters or 25 Feet
3. For the roads which come under the purview of Municipal Council
 - i. Roads starting from Main Street towards beach and local main roads - 03 Meters of 10 Feet
 - ii. Lanes and Crossroads other than the roads mentioned above - 2.25 Meters or 7.5 Feet.
