

RESOLUTION

Tangalle Urban Council by virtue of powers vested in, by Sub section 1 of Section 2 of the Entertainment Tax Ordinance (Chapter 267) resolves to impose and levy a tax on payments for admission to entertainment described in the regulation each magic show, circus show, musical show and horse riding, charging entertainment show held in the area within the administrative limit of the council to the value similar to 10% of such payments and the 7.5% of the value of tickets issued from the film show in cinema hall the same resolution shall come into operation with effect from the month after the month the proposal published in the *gazette* notice and proposed the council further proposes that the organizer or organizers of such an entertainment shall duly pay the respective tax to Tangalle Urban Council before the date of such entertainment.
