According to the powers vested on the Pradeshiya Sabha of the Ayagama to be read with the clause 122 by the rule 69/126 of the Provincial Coucil Act No. 15 of 1987 and the decision No. 5:1 taken by the general meeting of the Pradeshiya Sabha and agreed on 27.02.2019 and the Sub-laws of the 02nd Section of the Provincial Council Act, No. 12 - 1989 Consequential Provisions. I Tikiri Banda Kobbekaduwa as the Governor in the Sabaragamuwa Provincial Council will give my approval according to clause 123(1) for the said sub law and will declare that it will take effect in the jurisdiction of the Ayagama Pradesheeya Sabha from the date that it will be Gazetted in the Government Gazette.

#### By-laws on the Regulation, Controlling, Administration and Supervision of Weekly Fair in the Ayagama Pradeshiya Sabha

1.	This by -law shall be enacted in accordance with the powers vested in the Ayagama Pradeshiya Sabha under Section 126 of the Pradeshiya Sabha Act No. 15 of 1987.	Power to legislate to make by- law/legislative provisions
2.	This by-law shall be called the by-law of the maintenance of weekly fairs in the area of Ayagama Pradeshiya Sabha.	Name
3.	This By-laws shall be enacted for the Regulation, Controlling, Administration and Supervision of Weekly Fair in the Ayagama Pradeshiya Sabha	Subject matter and objectives of the by-law
4.	All the buildings of the Weekly fair shall be constructed of brick, stone or permanent construction material and shall be constructed at least six inches above ground level with concrete on the ground.	Functions to be performed
5.	The roof must be constructed of some permanent roofing material. Also, there should be a permanent system for drainage of rainwater collected from each roof.	
6.	The minimum distance between two rows of market stalls within the building shall be at least six feet wide, except in any reasonable case.	
7.	The pavement shall be constructed of permanent construction material suitable for the roaming of the customers and rain water shall be provided so as not to disturb the passenger roaming.	
8.	Every trade table built within the weekly fair shall be made of brick, cement, or cobble stone with a concrete slab or a stainless steel plate.	
9.	Howerver, when finished with a concrete plate, the layer must be plastered, polished, cemented, or ceramic.	
10.	Whenever there is no need to create trade table, the stripes that separate each part should be marked in white.	

- 11. Adequate number of separate toilets with special facilities for both men and women and people with special needs should be provided.
- 12. It is lawful to construct and maintain a restaurant or a tea or coffee shop within the weekly fair premises approved by the Council.
- 13. It is the duty of the council to supply electricity to every market place to suit the needs of the people.
- 14. The Ayagama Pradeshiya Sabha should take into consideration the location of the market place and distribute the meat, fish, dried fish, vegetables, fruit groceries and other commodities to the weekly fair market and It is also the job of the Ayagama Pradeshiya Sabha to display its layout at the entrance of the Weekly Fair.
- 15. Waste generated within the premises
  - I. Biodegradable waste;
  - II. the glasses;
  - III. Paper or paper-based materials;
  - IV. Polythene or plastic or polythene and plastic based materials and rigiforms;
  - V. Iron or other alloys or alloys of iron and other metals;
  - VI. Hazardous waste;

Separate collection bins or pots or tanks should be kept in a separate location in weekly fair and bin or tanks built for the disposal of biodegradable waste a proper method of disposal shall be prepared so that the rats, flies, insects or any other birds cannot enter or close well.

- 16. The Pradeshiya Sabha shall specify and mark the amount of space reserved for trading in any weekly fair.
- 17. At the fair, traders should wash their business premises or table at the end of their business.
- 18. All lights, fans and other electrical appliances in the premises should be deactivated at the time of the closing of the Weekly fair and leaving the trade table at any time.

Tasks that should not be done

- 19. Any item or goods brought to the Weekly fair for sale or any other instrument of trade or any other item in any manner other than when the goods or goods are brought into the weekly fair or in any case other than as provided in section 07 above shall not be allowed to do so or be placed outside the limits set for the specified trade.
- 20. Within the weekly fair, should not trade at any other place in the weekly fair except in places which boundaries are marked and permitted to operate within the premises permitted to trade and to engage in mobile trade and should not act in a manner that disturbs the pedestrian walk on the pavement parts.
- 21. No person shall be cooking at any other place within the premises of the Weekly fair except at the place mentioned in section 12 above.
- 22. At a weekly fair owned by the Ayagama Pradeshiya Sabha,
  - I. In subordination or harassment or drug, alcohol use or obscenity or begging;

- II. Staying inside the premises after the closing of the weekly fair at the end of the day;
- III. Damaging, destructing, distorting, or deformation of any flower bush, nameplate or other material which has been planted or kept for the purpose of constructing, installing or decorating a building;
- IV. Disinfecting or wasting or otherwise wasting the water supplied for use, or washing it with water, or washing clothes and fruits and washing vegetables or fruits in any place other than the place where received to wash fruits and vegetables;
- V. Place the goods in a way that prevents the electrical connection from reaching the main keyboard, or damages the main keyboard;
- VI. Fraudulently obtaining a water connection from the main water pipe or any other water pipe in the building;
- VII. Selling or displaying or displaying vegetable meat or fish anywhere in the premises other than for the purpose;
- VIII. Allowing or transporting bicycles, motorbikes or motor vehicles to places other than parking spaces set up within the weekly fair premises;
- 23. Any person who has recently contracted any infection, contact or dermatitis or who has recently undergone any such disease, should not engaged in any kind of trade in the weekly fair, unless the period of the infection and nutritional period has expired.
- 24. No person shall be allowed or engaged in any kind of trade in the Weekly Fair unless it is well worn and washed.
- 25. Any person should not exhibit sell or trade in the market premises any kind of good or material other than the place which has been reserved for the purpose of the sale of any kind of goods or materials by Ayagama Pradeshiya Sabha.
- 26. No meat shall be exhibited or stored for sale or sale in a market place at the Weekly fair unless it is the meat of an animal slaughtered in a slaughterhouse with a proper license under the Ayagama Pradeshiya Sabha.
- 27. In terms of the powers of Section 17 of the Tribal Ordinance, in a occasion which a decree has been published in the *Gazette* by prohibiting the slaughter of animals for slaughter on any given day in any slaughterhouse, no meat shall be kept or sold or displayed for sale in any meat stall maintained within the Weekly fair.
- 28. No person shall bring or bring a dog or cat or any other animal or bird inside the premises of the fair. This rule should not be understood as a rule that prevents police officers from bringing a police dog into the weekly fair for any investigative purpose.
- 29. A person who has obtained the use of a market place on a particular weekly fair shall not allow any person to exhibit or to display any part or all of the goods or goods in his place of business.
- 30. Any construction, installation or alteration of the design of any commercial premises of the Weekly fair, or any other type of structure, shall not be carried out, unless otherwise authorized by the Ayagama Pradeshiya Sabha.

- 31. No temporary or permanent change shall be made in or near the place of sale, or any curtain or roof, or any temporary or permanent change in the said market without the approval in writing of the Chairman or authorized officer.
- 32. No box, table, chairs or any such item belonging to the Ayagama Pradeshiya Sabha shall be brought or kept in or near the place of business or the installation of any shed or other equipment in the vicinity of a place of business.
- 33. An electrical circuit or a public water supply in the Weekly fair premises which has been supplied for public purposes shall not be permitted to tap or obtain a supply electricity to a shop.
- 34. It is lawful to obtain a sample of any food which has been displayed or stored for sale at a particular weekly fair by the Chairman or authorized officer of the Ayagama Pradeshiya Sabha by paying it's price and no person shall refuse or obstruct the purchase.
- 35. Reading the hand or propose to read the hand or prediction the future should not be done for any person who come to the weekly fair.
- 36. Any kind of medicines or drugs or dangerous or offensive or hazardous substances shall not be sold, kept for sale or advertised for sale.
- 37. Any kind of public speeches, religion propagate or preaching shall not be done.
- 38. Drugs should not be sold or advertised in the premises or in the vicinity of the premises or surrounding areas.
- 39. Advertising or marketing using loudspeakers or sophisticated high- tech sound amplifiers, should not be conducted on the premises for commercial purposes or any other purpose.
- 40. Notwithstanding section 39 of the above, the Chairman has powers to grant the use of a loudspeaker or modem high-tech sound equipment to inform the public of any urgent, crucial or public harm.
- 41. No person shall obstruct an authorized officer or officers of the coming council for collecting fees for the fair premise.
- 42. When the officer in charge of the fair, the Grama Niladhari or a police officer or any person acting on the authority of the chairman, orders to leave the land, any person must not wait for it to be disputed or to engage in a dispute with him without giving a satisfactory answer.
- 43. All vegetables, fruits, yams or any other foodstuffs for sale should not be adverse to public health.
- 44. The Ayagama Pradeshiya Sabha shall adhere to the following provisions of this by-law regarding a weekly fair maintained by the Council.
- 45. It is the responsibility of the Ayagama Pradeshiya Sabha to clean the premises of the Weekly fair on the day before the Weekly fair.
- 46. It is the function of the Ayagama Pradeshiya Sabha to disinfect every toilet in the Weekly fair by disinfecting it at least once a day and every drain which built for flowing water once on the Weekly fair day.
- 47. It shall be the duty of the Ayagama Pradeshiya Sabha to ensure that every bin, container or tank collected in the manner stipulated in section 12, shall be disposed of at least once a day on every day of the weekly fair and more than once if necessary.

Role of Local Authorities

- 48. From time to time the Council may decide the date and time at which any weekly fair maintained by the Ayagama Pradeshiya Sabha should be kept open. It shall be the Chairmen duty to make a notice in the three languages to make it publicly visible, at the entrance to the weekly fair, as to the dates and times of the opening of the weekly fair as determined by the Council.
- 49. Maintaining peace within the fair premises shall be done by an officer or officers appointed by the Council and acting on the premises.
- 50. Every person who comes to the market to buy or sell goods must comply with any lawful order made by an officer of the congregation or a police officer to settle any dispute or to preserve peace.
- 51. Any person trading in weekly fair places should not engage in an trade activity unless the permit prepared by the Ayagama Pradeshiya Sabha has been paid in full in accordance with the first schedule of this by-law. It shall be lawful for such fees to be imposed, modified or amended by the Ayagama Pradeshiya Sabha.

Charges & Recovery

- 52. Any person authorized by the Secretary may be authorized to issue permits and to charge money for such permits for the people who wish to use the fair premises.
- 53. No money should be charged at the weekly fair without issuing a permit, and it shall be the duty of the collector to deposit the collected money to the pradeshiya sabha fund as prescribed by the council.
- 54. If any person authorized by the Secretary is unable to engage in the issuance of permits and to collect money for the use of the shops and trade tables of the Weekly Fair and to collect money for the purpose the Ayagama Pradeshiya Sabha shall have the authority to delegate such work to a person selected by public tenders.
- 55. Assignment of such work to a tenderer selected under Article 51 shall be valid for one year only and a bidder must be selected by calling for a re-tender for the following year. However, any tenderer selected for the previous year shall not be interpreted by the provisions of this by-law to be the tenderer's application for the successive year if the Council decides to submit the tender application for the successive year and accept the tender application.
- 56. Any fee collector shall not charge any fee or fee exceeding the rates determined by the Ayagama Pradeshiya Sabha for the use of the Marketplace in any weekly fair under the provisions of Article 48.
- 57. The council should take steps to enter into a formal agreement with the bidder selected to collect the weekly fees.
- 58. Any person who has obtained a permit under Article 50 of the Act to use or operate a certain market place shall not alienate the said
- permit or trade in any premises other than the same premises and when the Chairman or authorized officer of the Ayagama Pradeshiya Sabha is satisfied that such person has acted, the Chairman or the authorized officer shall have the right to direct the merchandise at his place of business or to remove the weekly fair or the cancellation of the permit issued to him.
- 59. Any dispute arising out of the use of the Weekly Fair between the holders of valid license issued by the Council or those under the authority of such license holders, or between the license holders and the public, may be settled by the Chairman or by any officer authorized by the Chairman.
