According to the judgment pronounced in the case numbered above, the above defendant has been fined Rs. 2,149,792 and a legal interest of 14% up to Rs. 1,886,920.20 plus legal fees of Rs. 149,002.50 and an amount of Rs.4,185,714.75 has been ordered to be paid to the complainant.

Further, in order to obtain the aforesaid amount of money, the houses, lands and goods of the accused have been banned and if necessary, the court has ordered that the plaintiff should recover the amount due against the defendant by this declaration of judgement.
