IT is hereby noticed that Ocean Aqua Farm has requested the state land allotment in extent of 9 Acres in the amount of land indicated in the part of the gross tracing undersigned by the Divisional Secretary situated in the Village of Araliturai of Velanai Northeast (J/13) Grama Niladhari Division which belongs to Velanai (Islands South) Divisional Secretary's Division in District of Jaffna on lease for Commercial activities (a Crab Farming Project)

In the instances where the valuation of land in the year of 2022 is more than Five Million Rupees (Rs. 5,000,000), 4% of the market value of the land in the said year, as per the valuation of the Chief valuer. This amount of the lease must be revised in every five years and the revision shall be added a 20% of the amount that just preceded.

Premium: Not levied.

- (c) The lessees must not use the said land for any purpose what so ever other than for Commercial activities (a Crab Farming Project);
- (d) The lessees must, within a period of one (01) year from the date of Commencement of the lease, develop the said land to the satisfaction of the Provincial Land Commissioner/ Deputy Land Commissioner/ Divisional Secretary;
- (e) This lease shall also be subject to other special conditions imposed by the Provincial Land Commissioner/ Divisional Secretary and other institutes;
- (f) Existing/ Constructed buildings must be maintained in a proper state of repair;
- (g) If the lessee fails to substantiate the purpose for which the land was obtained within the specified period of

- time, steps will be taken to cancel the agreement of lease;
- (h) No permission will be granted, until expiry of 05 years from the date 30.06.2022 for subleasing or assigning;
- (i) Payment of the lease rental must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse.
- (*j*) A penalty of 10% will be added in case of non payment of lease rental regularly.

If acceptable reasons are not submitted to me in writing within 06 weeks of herein *Gazette* publication to the effect that this land must not be given on lease, the land shall be leased out as requested.
