All Government Departments, corporations, Boards, etc. are hereby advised that Notifications fixing closing dates and times of applications in respect of Post-Vacancies, Examinations, Tender Notices and dates and times of Auction Sales, etc. should be prepared by giving adequate time both from the date of despatch of notices to Govt. Press and from the date of publication, thereby enabling those interested in the contents of such notices to actively and positively participate please note that inquiries and complaints made in respect of corrections pertaining to notification will not be entertained after **three months** from the date of publication.

All Notices to be published in the weekly *Gazettes* should reach Government Press two weeks before the date of publication *i.e.* Notices for publication in the weekly *Gazette* of 20th May, 2022 should reach Government Press on or before 12.00 noon on 6th May, 2022.

#### NOTIFICATION UNDER STATE LAND REGULATION No. 21(2)

IT is hereby noticed that Sustainable Green Energy Private Ltd. has requested a state land allotment in extent of 09 acres depicted in the sketch and situated in the Village of Kaththarsinnakulam of No. 215 B, Kaththarsinnakulam Grama Niladhari division which belongs to Vavuniya Divisional Secretary's Division in the District of Vavuniya on lease under the State Lands Ordinance for Commercial Purpose.

02. The boundaries of the land requested are given below:-

*On the North by* : Land belongs to P. Pathmanadan;  
*On the East by* : Road;  
*On the South by* : kaththarsinnakulam -  
Karuvlapuliyankulam road;  
*On the West by* : Land belongs to Rathnam;

The requested land can be granted lease for the necessary purpose. Therefore, the government has intended to lease out the land subject to other government approved conditions and the following conditions.

(a) *Terms of the lease* : Thirty Years. (30) (From 29.03.2022 to 28.03.2052)

*Annual amount of the lease* : In the instances where the valuation of land in the year 2022 is less than Five Million rupees (Rs. 5,000,000), 2% of the market value of the land in the said year, as per the valuation of the Chief Valuer. In the instances where the valuation of land in the effective year of lease is more than Five Million Rupees (Rs. 5,000,000), 4% of the market value of the land in the said year, as per the valuation of the Chief Valuer. This amount of the lease must be revised in every five years and the revision shall be added a 20% of the amount that just preceded.

*Premium* : Not levied.

- (b) The lessees must, within a period of one (01) year from the date of commencement of the lease, develop the said land to the satisfaction of the Divisional Secretary;
- (c) The lessees must not use the said land for any purpose what so ever other than a Commercial Purpose;
- (d) This lease shall also be subject to the other special conditions imposed by the Provincial Land Commissioner/ Divisional Secretary and other institutes ;
- (e) Existing buildings must be maintained in a proper state of repair;
- (f) If the lessee fails to substantiate the purpose for which the land was obtained within the specified period of time, steps will be taken to cancel the agreement of lease;
- (g) No permission will be granted until expiry of 05 years from 29.03.2022 subleasing ;
- (h) Payment of the lease rental must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse.

If acceptable reasons are not submitted to me in writing within 06 weeks of herein *Gazette* publication to the effect that this land must not be given on lease, the land shall be leased out as requested.
