### NOTIFICATION UNDER STATE LAND REGULATION No. 21(2)

IT is hereby noticed that Mr. Navarathna Pahala Gedara Sanjeewa Ruwansiri Wijerathna has requested a state Land allotment in extent of 02R, 38.38P depicted in the tracing of Colonization Officer and situated in the Village of Kantale of No. 227L, Bhathiyagama Grama Niladhari Division which belongs to Kantale Divisional Secretary's Division in the District of Trincomalee on lease for Commercial Purpose.
