Press and from the date of publication, thereby enabling those interested in the contents of such notices to actively and positively participate please note that inquiries and complaints made in respect of corrections pertaining to notification will not be entertained after **three months** from the date of publication.

All notices to be published in the weekly *Gazettes* should reach Government Press two weeks before the date of publication *i.e.* Notices for publication in the weekly *Gazette* of 09th September, 2022 should reach Government Press on or before 12.00 noon on 26th August, 2022.

AN ACT TO INCORPORATE THE SUSARANA LANKA FOUNDATION

I, Asanka Navarathna, do hereby give notice under Standing Order No. 53(1) of the Standing Order of the Parliament of the Democratic Socialist Republic of Sri Lanka, that I propose to introduce to Parliament a Bill titled "An Act to incorporate the **Susarana Lanka Foundation**".
