All notices to be published in the weekly *Gazettes* shall close at 12.00 noon of each Friday, two weeks before the date of publication. All Government Departments, corporations, Boards, etc. are hereby advised that Notifications fixing closing dates and times of applications in respect of Post-Vacancies, Examinations, Tender Notices and dates and times of Auction Sales, etc. should be prepared by giving adequate time both from the date of despatch of notices to Govt. Press and from the date of publication, thereby enabling those interested in the contents of such notices to actively and positively participate please note that inquiries and complaints made in respect of corrections pertaining to notification will not be entertained after **three months** from the date of publication.

All notices to be published in the weekly *Gazettes* should reach Government Press two weeks before the date of publication *i.e.* Notices for publication in the weekly *Gazette* of 10th February, 2023 should reach Government Press on or before 12.00 noon on 27th January 2023.

### AN ACT TO INCORPORATE THE S O S CHILDREN'S VILLAGE OF SRI LANKA ORGANIZATION

### AN ACT TO INCORPORATE THE PRAGNABANDU SCHOLARSHIP TRUST FUND

I, Rupasinhage Pradeep Saman Kumara Undugoda, do hereby declare that I intend to present in the Parliament a draft bill titled "An Act for the incorporation of the Pragnabandu Scholarship Trust Fund" under Standing Order 53(1) of the Standing Orders of the Parliament of the Democratic Socialist Republic of Sri Lanka.

The object of the Bill is to incorporate the said scholarship trust fund having the following objectives. The objects of the fund are -

01. to grant scholarships to qualified young men and women according to their situation who have successfully completed their primary education in order to extend financial assistance for them to complete higher education to develop their industrial and/or technical and/or vocational skills in a technical and/or higher education institution.
02. to establish or extend assistance to establish higher education institutes, schools, funds in other fields of education and/or technology/management and/or establish similar institutes for the furtherance of higher education.;
03. to grant aid for developing and upgrading skills and competencies lecturers, teachers and such other persons engaged in the advancement of technical education,
04. to do all/other such things required or appropriate for the realization of the aims and objectives of the Fund.
