Notification Under State Land Regulation No. 21 (2)

IT is hereby notified that Gabadage Buddhika Thushara Jayavilal has requested an allotment of state land in extent of 02 Acres, 03 Rood, 25.8 Perches depicted as Lot No. A in the Tracing No. 1721, situated in the Village of Palatupana in the Grama Niladhari Division No. 19 of Kirinda which belongs to Thissamaharama Divisional Secretary's Division in the District of Hambantota, for a Tourist Hotel Project.

02. The boundaries of the land requested are given below:

- 03. The requested land can be granted on lease for the necessary purpose. Therefore, the government has intended to lease out the land subject to other Government approved conditions:
 - (a) Term of the lease: Thirty Years (for 30 years ahead from 29.03.2023).

The Annual amount of the lease: 4% of the market value of the land in the year 2023, as per the valuation of the Chief Valuer. This amount of the lease must be revised in every 05 years and the revision shall be less than 50% of the amount recovered at the end of the 05 years just preceded.

Premium – Thrice as the annual lease.

Fine – 10% of the Undeveloped Commercial Value of the Land in the Year 2023.

(b) The lessees must, within a period of one (01) year from the date of commencement of the lease, develop the said land to the satisfaction of the Divisional Secretary;

- (c) The lessee must not use the said land for any purposes what so ever other than Hotel Project Purpose;
- (d) This lease shall also be subject to the other special conditions imposed by the Provincial Land Commissioner/Divisional Secretary and other Institutions;
- (e) Existing/ Constructed buildings must be maintained in a proper state of repair;
- (f) If the lessee fails to substantiate the purpose for which the land was obtained within the specified period of time, steps will be taken to cancel the agreement of lease;
- (g) No permission will be granted, until expiry of 05 years from the year 29.03.2023, for subleasing or assigning for any other purpose;
- (h) Payment of the lease rental must be regularly made and if defaulted in payment, the agreement will *ipso facto lapse*. In instances where payment of the lease

rental is not regularly made, default interest of 10% shall be levied on the defaulted lease payable.

If acceptable reasons are not submitted to me in writing within 06 weeks of therein *Gazette* publication to the effect that this land must not be given on lease, the land shall be leased out as requested.
