All notices to be published in the weekly *Gazettes* should reach Government Press two weeks before the date of publication *i.e.* Notices for publication in the weekly *Gazette* of 8th November 2024 should reach Government Press on or before 12.00 noon on 25th October 2024 **Electronic Transactions Act, No. 19 of 2006 - Section 9**
