#### Notification under State Land Regulation No. 21 (2)

IT is hereby noticed that for the commercial purpose, Mr. Dissanayake Mudhiyanselage Ranthev Nilkamal Dissanayake has requested on lease a State land containing in extent about 01 Acre, 21 Perches depicted in tracing drawn by the land officer (Provincial) in the Village of Habarana which belongs to the Grama Niladhari Division No. 589, Habarana coming within the area of Authority of Palugaswewa Divisional Secretariat in the District of Anuradhapura.

*Premium* : premium will not be charged;

- (b) The lessees must, within one year (01) of the commencement of the lease, develop the said land, in such a manner as to captivate the mind of the Divisional Secretariat;
- (c) The lessee must not use this land for any purpose other than for commercial purposes;
- (d) This lease must also be subject to the other special conditions stipulated and imposed by the Provincial Land Commissioner/ Divisional Secretary and other institutions;
- (e) The buildings constructed/ being constructed must be maintained in a proper state of repair;
- (f) Once the Land is given on lease and in the event of a failure on the part of lessees to substantiate within the specified time frame the purpose for which the land was obtained, action will be taken to terminate the lease;
- (g) No subleasing or transfer other the subleasing or transfers to realize the fact of the lease of this land shall be permitted till the lapse of five year from 16.11.2022;
