All Notices to be published in the weekly *Gazette* should reach Government Press two weeks before the date of publication *i.e.* Notices for publication in the weekly *Gazette* of 28th March, 2025 should reach Government Press on or before 12.00 noon on 14th March, 2025.

THE SUGGESTION

In terms of the powers given to the Local Councils under Section 139 of the Local Council Act, No. 15 of 1987, for the purpose of assessing the annual value of any house, building, land or plot of land for the purpose of assessment within the jurisdiction of Thawalama Pradeshiya Sabha and or for the purpose of assessing the extent of any cultivated land for the purpose of acre tax, to facilitate the provision of development works within the jurisdiction of the Local Council and to create an information system for the purposes of Sections 3 and 5 of the Right to Information Act, No. 12 of 2016. The owner and occupier of such a property should be required to furnish periodical reports regarding its rent or annual value or its size and other matters, suggests the Thawalama Pradeshiya Sabha.
