Ceylon Cinnamon refers to the specific cultivated species of cinnamon indigenous to Sri Lanka (Ceylon). Cinnamon is presented in a number of forms such as Quills, Cut quills, Powder, Leaf Oil, Bark oil. Ceylon Cinnamon has a pronounced sweet and citrus aroma with a note of honey and has pale brown to slightly reddish colour, ground cinnamon –golden yellowish to browning.

3. Concise Definition of The Geographical Area

The geographical area extends to the whole Island of Sri Lanka, an area of 65,651 km², which has a uniform climatic and agronomic conditions defined by a distinctive pattern of two annual monsoons, with resultant rainfall patterns, consistent patterns of sunshine, and consistent soil and other agronomic characteristics. The request to register ‘Ceylon Cinnamon’ is based on the qualities, characteristics and reputation of the products.

3.1 Specificity of the geographical area: Environmental factors

In Sri Lanka, Cinnamon is cultivated under varying conditions ranging from semi-dry to wet zone conditions and soils from silver sand to loamy and lateritic to gravelly soils of Sri Lanka. The most suitable temperature is between 25⁰C and 30⁰C. Rainfall in the region is between 1,250- 3,500mm. Cinnamon is grown commercially in all parts of the Island.

The soil texture has a nice share of sand, which is well appreciated by the plant. The presence of this sandy fraction in the soil, added to the wet climate lead to perfect irrigation and good draining.

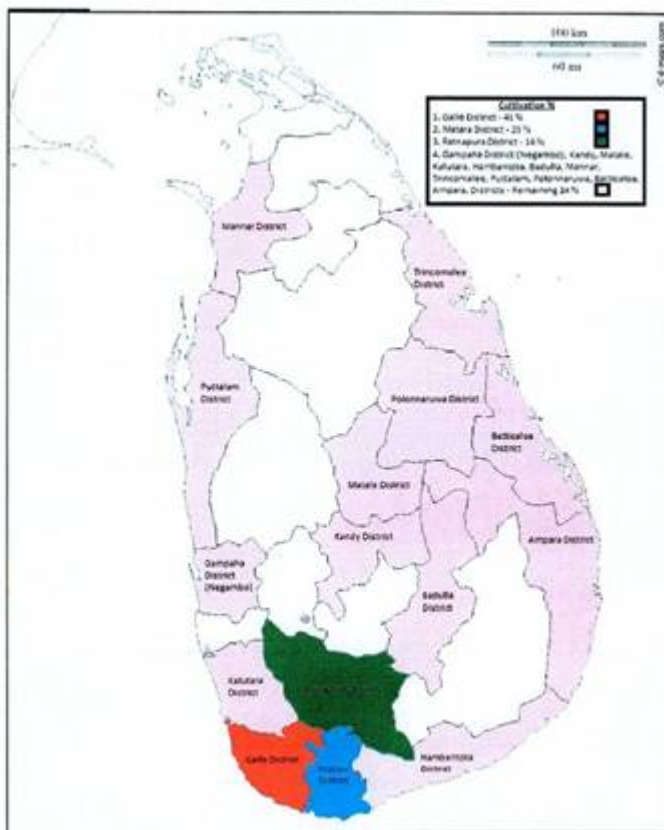
Ceylon Cinnamon has a reputation dating back many centuries. The Following key-points of quality of the Ceylon Cinnamon linked to the origin can be highlighted as:

- The Cinnamon tree is indigenous to Sri Lanka and not to other origins;
- Soil and climate; grown in various types of soils varying from silver sands and temperature is between 250 C- 320 C;
- Texture provided by high rainfall in the region of 1,250 – 3,500 mm per annum;
- Traditional Knowledge in harvesting, peeling, drying, preparing the quills and drying again;
- Shared understanding of quality grading, which was established long before and serves as reference for pricing.
