## Examinations, Results of Examinations, & c.

### OPEN COMPETITIVE EXAMINATION FOR RECRUITMENT TO THE POST OF APPRENTICE AYURVEDA PHARMACIST (TRAINEE GRADE) OF THE NORTH WESTERN PROVINCIAL DEPARTMENT OF AYURVEDA - 2015

APPLICATIONS are hereby called from the permanent residents (male/female) of the North Western Province who have fulfilled the following qualifications, for recruitment to the post of Apprentice Ayurveda Pharmacist (Trainee Grade) of the North Western Provincial Department of Ayurveda.

1. It is notified that this examination will be conducted in an examination centre set up by the North Western Provincial Council Public Service Commission in the city of Kurunegala. The North Western Provincial Council Public Service Commission reserves the right to postpone or to cancel the examination.
2. *Salary Scale* .- The monthly salary scale applicable to this post in terms of the Public Administration circular 06/2006 (IV) is MT 2/2006A is, Rs. 14,570 - 10x170 - 11x180 - 6x240 - 14x320 - Rs.24,170
3. (a) *Educational Qualifications* .- Should have passed 06 subjects in one and the same sitting of the General Certificate of Education (Ordinary Level) Examination with 04 Credit passes for Sinhala/Tamil/English Language, Mathematics/Arithmetic, Science/Health Science and one other subject.

and

Should have passed 03 subjects including Biology and Chemistry under the new syllabus or Botanical Science and Chemistry under the Old syllabus of the General Certificate of Education (Advanced Level) Examination at the same sitting.

The above educational qualifications should have been completed and obtained the certificates on or before 30.06.2015.

(b) *Other qualifications* .–

- I. *Age limit* .— Should be above 18 years and not more than 30 years. (the upper age limit will not be applicable to those who are already in the permanent Public/Provincial Public Service).
- II. Should be a Sri Lankan Citizen.
- III. Should be a permanent resident of the territory of the North Western Provincial Council for a period of 03 years to the closing date of applications. (Permanent residency should be proved by a residency certificate issued by the Grama Niladhari certified by the Divisional Secretary)
- IV. Should have an excellent moral character.
- V. *Technical Competency/Proficiency*  
Applicants selected for the appointment should undergo two-year training in Ayurveda Pharmaceuticals at the Institute of Indigenous Medicine and should obtain the certificate and get registered with the Ayurvedic Medical Council as a Ayurveda Pharmacist

Applicants who pass the open competitive examination will be called for an interview and the selected applicants will be appointed to the post of Apprentice Ayurveda Pharmacist (Trainee Grade) by the North Western Provincial Public Service Commission. Appointees will be directed to the Institute of Indigenous Medicine to undergo the two year training programme in Ayurveda Pharmaceutics. They will be paid a monthly salary of Rs. 12,360 during the training.

- VI. Apprentice Ayurveda Pharmacists who obtain the professional qualification by completing the above training programme will be placed on the initial salary step of the MT2/2006A Salary scale with effect from the date of obtaining the professional qualification.

4. *Conditions of Service* .—

- I. This post is permanent and pensionable. Contribution should be made to the Widow/Widowers and Orphans Pension Scheme.
- II. This appointment is subject to a probation period of three years and if the work and the conduct is satisfactory during the probation period and if the first EB examination is passed and the other requirements fulfilled, the appointment will be confirmed at the end of the probation period.
- III. Provisions of the sections 10 to 12 of the Chapter II of the Volume I of the Establishment Code will be applicable to the post as appropriate.
- IV. The appointees should abide by the regulations of the Establishment Code of the Democratic Socialist Republic of Sri Lanka, Financial Regulations, Departmental Regulations, Provincial Financial Regulations, Provincial Disciplinary Procedure Code, Regulations of the Government and the North Western Provincial Council already issued and will be issued from to time.

5. *Method of Recruitment*.— Recruitment will be made through an interview to verify the qualifications where the number of applications are less than the number of vacancies. Recruitment should be made on the results of an examination conducted by the North Western Provincial Public Service Commission where the number of applications are higher than the number of vacancies. 70% of the vacancies will be filled through this examination. A Shortlist in order of merit will be prepared after selecting the applicants who shall secure at least 40% of marks of above for each and every subject mentioned in the examination syllabus. Shortlisted applicants will be called for an interview to verify their qualifications according to the order of merit and the number of vacancies. (marks will not be given at the interview)

6. *Examination Procedure* .—

*Note :*

- I. These question papers shall be prepared to test the aptitude and the ability of the applicants for official duties.
  - II. Illegible handwriting and the spelling mistakes will be penalized.
  - III. 40% of the marks or above should be obtained for each and every subject. Vacancies will be filled according to the order of merit and the number of vacancies.
  - IV. Medium of Examination : Applicants must sit all the papers of the examination in one and the same language on their choice.
7. A sum of Rs. 500 being the examination fee should be paid to the Divisional Secretariat of the area of permanent residence to be credited to Revenue Head 200-02-13 of Secretary, North Western Provincial Council Public Service Commission and the receipt WPSM/2 obtained from the Divisional Secretariat should be affixed to the application. Receipts other than the receipts obtained from the Divisional Secretariat or Money Orders will not be accepted and it should be noted that the examination fee is non-refundable under any circumstance.
8. *Method of Application* .—
- 8.1 Applications should be prepared in A4 size (21cm x 29cm) paper using the both sides as per the specimen application given at the end of this notification. Duly filled applications should be sent under registered cover to reach “Secretary, North Western Provincial Council Public Service Commission, Provincial Council Complex, Kurunegala.” The words “Open Competitive Examination for the Recruitment to the post of Apprentice Pharmacist (Trainee) - 2015” should be clearly indicated on the top left hand corner of the envelope enclosing the the application.
  - 8.2 Officers who are already serving in the Public or Provincial Public Service should forward their applications through their Heads of the Department.
  - 8.3 Applications that do not comply with the specimen application form, do not include receipts of payment of examination fees before the due date, which are incomplete and received after the closing date will be rejected without any notice. Further, it is the responsibility of the applicants to make sure that the completed application form complies with the specimen. Applicants should bear the responsibility of the losses due to non-completion of the applications accurately. The receipt of the applications will not be acknowledged.
9. Closing date of applications is 30.06.2015.
10. Applications of the candidates who have not fulfilled the qualifications mentioned in this notification will be rejected. The issuance of an admission card to a candidate does not mean that he or she has fulfilled the requisite qualifications to sit for the examination. Originals of the relevant documents to prove the qualifications should be submitted at the interview. It is compulsory that all the candidates must fulfill all the relevant requirements on or before the closing date of applications.
11. *Identity of the applicants* .— Every applicant should prove his/her identity by producing the following documents at the examinations hall to the satisfaction of the supervisor of the examination hall .
1. National Identity Card issued by the Department of Registration of persons.

14. The decision of the Public Service Commission, North Western Provincial Council is final and conclusive with regard to any matter related to this notification or any other matter not provided in the notification.
15. The North Western Provincial Council Public Service Commission reserves the decision of conducting or not conducting this examination, filling or not filling the vacancies and the number of vacancies.
