**MORATUWA MUNICIPAL COUNCIL**

**Imposition of Assessment Tax for the Year - 2018**

WHILE cancelling the *Gazette* notification dated 15.09.2017 issued by the Moratuwa Municipal Council with regard to the imposing of assessment tax the following *Gazette* notification issued in lieu thereof to be effective from 01.01.2018.

I, Santha P. Liyanage, Municipal Commissioner of Moratuwa Municipal Council who is discharging the duties and functions relevant to the implementation of the powers of Moratuwa Municipal Council, decide that fixing of

assessment taxes relating to the year 2018 for Moratuwa Municipal Council area should be as set out below in terms of provisions under Section 286(a) of the Municipal Ordinance to be read with Section 230(1) of the said Ordinance.

I decide that the said revised valuation be accepted for 2018 as well, and in terms of the powers vested on the Moratuwa Municipal Council under Section 238(1) of Municipal Ordinance and the valuation/verification for the year 2017 be accepted as the valuation for the year in respect of houses, buildings, lands in the Moratuwa Municipal Council administrative limits and assessment taxes be levied as follows in according with the powers vested on me by Section 286(a) to be read with Section 230(1) of Municipal Ordinance.

- (a) Assessment Tax of 7% of the annual value from all residential premises.
- (b) Assessment Tax of 16% of the annual value in respect of all other non residential premises such as commercial, industrial, government Departments, Corporations statutory Boards etc.
- (c) 20% tax of the annual valuation from barren lands and buildings under construction.

I further decide under decision No. 2091 dated 27.12.2017 that the Annual Assessment Tax described against each quarter mentioned in the Schedule below for the year 2018 should be paid to the Moratuwa Municipal Council fund, and if the Annual Assessment Tax is paid on or before 31st January 2018 a discount of 10% of the Annual Assessment Tax and if the relevant assessment tax is paid to the Moratuwa Municipal Council fund before the date mentioned against each quarter in the said Schedule a discount of 5% of the amount applicable for each quarter should be given.
