### NOTIFICATION MADE UNDER STATE LAND REGULATION No. 21 (2)

IT is hereby notified that Arachchikattuwa Multipurpose Cooperative Society has requested the state land allotment in extent of 01 R, 26 P depicted as Lot No. 177 in the plan Pu. 81 and situated in the village of Pahala Aththanganaya in No. 592 F Grama Niladhari division which belongs to Arachchikattuwa Divisional Secretary's Division in the District of Puttalam on lease for the purposes of the Society.

(b) The lessees must, within a period of one year from the date of commencement of the lease, develop the said land to the satisfaction of the Divisional Secretary;

(c) The lessees must not use the said land for any purpose what so ever other than for the purposes of the Society ;

(d) The lease must also be subject to the other special conditions imposed by the Divisional Secretary and other Institutes;

(e) Constructed/existing buildings must be maintained in a proper state of repair ;

(f) If the lessee fails to substantiate the purpose for which the land was obtained within the specified period of time, steps will be taken to cancel the agreement of lease ;

(g) No. permission will be granted until expiry of 05 years from 08.11.2013 for any other subleasing or assigning other than assigning or subleasing to substantiate the purpose of which the land was obtained ;

(h) Payment of the lease rental must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse;

If acceptable reasons are not submitted to me in writing within six weeks of herein *Gazette publication* to the effect that this land must not be given on lease, the land shall be leased out as requested.
