Press and from the date of publication, thereby enabling those interested in the contents of such notices to actively and positively participate please note that inquiries and complaints made in respect of corrections pertaining to notification will not be entertained after **three months** from the date of publication.

All Notices to be published in the weekly *Gazette* should reach Government Press two weeks before the date of publication *i.e.* Notices for publication in the weekly *Gazette* of 10th April, 2026 should reach Government Press on or before 12.00 noon on 27th March, 2026.

“By virtue of the powers vested in the Pradeshiya Sabha under Section 126(x) (a), (b), (c), (d), (e) of the Pradeshiya Sabha Act, No. 15 of 1987, and considering that there are four weekly fairs within the administrative limits of the Pradeshiya Sabha and that permanent vegetable and grocery trading establishments exist in various locations, it has been unanimously resolved by the Council that permission shall not be granted for mobile vegetable and grocery trading within the jurisdiction of the Pradheshiya Sabha.

However, in order to ensure that local producers are not affected, permission will be granted only for the sale of their own produce by using two-wheel vehicles.”
