Under Sections 147, 149, 150(1)(2), 151, 152(1), and 154 of the Pradeshiya Sabha Act, No. 15 of 1987, with effect from 01 January 2026, the taxes, license fees, and charges relating to the businesses, trades, vehicles, and animals listed in the schedules below will be levied. In addition to these, other government taxes will also be charged where applicable. The relevant annual license fees and taxes on vehicles and animals for each year must be paid within the first three (03) months — from 01 January to 31 March of the respective year — at the offices of the Velanai Pradeshiya Sabha including Velanai, Mandaitivu, Allaippiddy, Pungudutivu, and Nainativu sub-offices. This decision has been approved by Council Resolution No. 40 dated 19.11.2025. Failure to make the required payments within the specified period will result in legal action being taken in court in accordance with the Pradeshiya Sabha Act.

Levy of Tax on Undeveloped Lands

Notice is hereby given that in terms of Section 153 of the Pradeshiya Sabhas Act, No. 15 of 1987, it has been decided by Council Resolution No. 41 dated 19.11.2025 to levy and recover a tax on undeveloped lands within the administrative limits of the Valanai Pradeshiya Sabha, with effect from the Year 2025, as specified below.

Notice under the National Environmental Act

Accordingly, in order to issue *Environmental Protection Licenses* by the Velanai Pradeshiya Sabha in accordance with the following provisions, this Act shall be implemented within the administrative limits of the Velanai Pradeshiya Sabha. Application fees, license fees, inspection fees, and order fees in respect of the industries specified in the Schedule below shall be levied and recovered as determined by the **Central Environmental Authority**.

The fees so collected shall be in addition to the license fees imposed and collected under the Pradeshiya Sabhas Act, No. 15 of 1987, and shall not in any way affect such license fees. This notification shall come into operation from the date of its publication in the *Gazette*. It is further notified that, by Council Resolution No. 43 dated 19.11.2025, it has been decided that legal action will be instituted in a court of law against persons who fail to make the required payments in accordance with the provisions of the Pradeshiya Sabhas Act.

Approval for Building Construction and Levying of Fees

NOTICE is hereby given that Council Resolution No. 45 dated 19.11.2025 has been adopted to take action, within the administrative limits of the Velanai Pradeshiya Sabha, in accordance with Sections 47 to 59 of the Pradeshiya Sabhas Act, No. 15 of 1987, together with the provisions of the Town and Country Planning Ordinance and the Regulations made under the Urban Development Authority Act, No. 41 of 1978. However, where the owners of the premises furnish a written undertaking that they will not claim compensation in the event of road widening, building applications shall be considered subject to the following minimum road widths:

Recovery of Fees for the Velanai Pradeshiya Sabha Boat Service
