All Notices to be published in the weekly *Gazettes* should reach Government Press two weeks before the date of publication *i.e.* Notices for publication in the weekly *Gazette* of 15th May, 2026 should reach Government Press on or before 12.00 noon on 30th April, 2026.

THE SAID SCHEDULE

Notification regarding the cancellation of the main Grant issued under Section 19(4) under Sub Section (Section 104) of the Land Development Ordinance

I, Elaboda Gedara Upali Rajapaksha, Divisional Secretary of Rajanganaya Divisional Secretariat in the Anuradhapura District, North Central Provincial Council, hereby notify that the grant bearing Number Anu/Raja/5029, issued by His Excellency the President on 05.12.2000 to Ambawalage Asilin Nona, residing at Tract 18, Rajanganaya and registered in the Registrar's Office of the Anuradhapura District under Number 2042 on 24.04.2001, page 415/172, will be canceled, as this action is taken under Section 104 of the said ordinance, as no legal heir exists, or if there is a legal heir, he/she is unwilling to claim succession rights.
